Subject:- Appointment to the post of Inspector Food Civil Supplies.

On the recommendations of Haryana Staff Selection Commission, Panchkula vide letter No HSSC/Conf./Recomm/2021/585, dated 21.10.2021, you are hereby offered an appointment to the post of Inspector Food, Civil Supplies & and Consumer Affairs, Department on temporary basis in the Food and Supplies Department, Haryana in the pay scale of Rs. 9300-34800+3600 G.P. (Now FPL-6 of Pay Matrix Table in the Haryana Civil Services (Revised Pay) Rules, 2016) plus usual allowances sanctioned by Haryana, Government from time-to-time on the following terms and conditions:-

- (i) This appointment is purely temporary and you will remain on probation for a period of two years which can be extended after taking into consideration your work and conduct to a total period not exceeding three years. Your services are liable to be terminated without notice on the abolition of the post or on the termination of vacancy or leave arrangement or any other arrangement against which you happened to be working at that time.
- (ii) If at any stage you desire to resign from your post in the Food Civil Supplies & Consumer Affairs Department, you will be required to give one month's clear notice or forfeit, in lieu thereof, one month salary including allowances or for the period by which the notice falls short of one month. Such a notice will be given to you by the department also in case it is proposed to terminate your service for the reasons other than that mentioned in Para-1 above. In case of misconduct or misbehaviour, however, you will be given a reasonable opportunity to show cause as to why your services be not terminated, in that case the condition of one month's notice/salary will not apply.

- (iii) As your character and antecedents have not been verified in terms of Government instructions issued vide memo No. 52/3/20058-6S(1), dated the 18th November, 2005 & subsequent State Govt. order dated 52/18/-3G-III, dated 10.01.2019. However, it is made clear that your appointment will remain provisional basis without prior verification of your character and antecedents. In case, subsequently any adverse fact come to the notice of this office regarding your character and antecedents, your services are liable to be terminated immediately without any notice and without prejudice to such further action as may be taken under provision of the Indian Penal Code for production of false Certificates/Statement/Attested copies. The Character & Antecedents will, however, be got verified within a period of two months after your provisional appointment and this relaxation does not confer any right to you to remain in job, if subsequently anything adverse is reported against you at a later stage.
- (iv) As the authenticity of your academic qualifications, caste and category certificates has also not been verified/checked from the issuing authority, and the same are required to be got verified within a period of two months after your provisional appointment, therefore, it is made clear to you that if at any subsequent period, the same are found to be fake/false, your services are liable to be terminated and legal action will also be taken against you in this regard.
- (v) Your services will be governed by the provisions contained in the Haryana Civil Services Rules, 2016 as applicable to Haryana Government employee and the Haryana Food and Supplies Department Sub-Offices (Group-C) Service Rules, 1982 as may be amended from time to time and also the Government instructions issued in this regard.
- (vi) Further, it is made clear to you that your services will be governed under the Finance Department Notification dated 28.10.2005, No. 1/1/2004-1 Pension (FD), dated 22.12.2005 & various provisions contained in Haryana Civil Services Rules, 2016 as amended from time to time and your services will be covered by the new defined contribution Pension Scheme as your fresh appointment is being made after 01.01.2006.
- (vii) It is also made clear to you that you will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies or examination.
- (viii) No T.A./D.A. will be granted for joining the post in the Department.
- (ix) You are liable to serve in any place whether within or outside the State of Haryana or in the office central or other State Government or a company, an Association or a body of individuals whether incorporated or not Municipal Corporation or local authority or an international organization, an autonomous body not controlled by the Government or a private body.
- (x) Your seniority will be fixed as per rules/instructions.
- (xi) Before regular charge of duties is given to you, you will be required to undergo a course of training as prescribed by the department. However, you will get the pay in the regular pay scale during the period of training also.

- (xii) Before assuming the charge of duties, you will be required to take the prescribed oath of allegiance to the Constitution of India and to produce the following certificates/security to the concerned Distt. Food & Supplies Controller:-
- (a) You shall have to furnish a Medical fitness certificate from your nearest Chief Medical Officer/Civil surgeon before joining to the above post under rule 9 of Haryana Civil Services (General) Rules, 2016, in case you are found medically unfit then your services will be terminated without giving any notice as required under Rule 10 of Haryana Civil Services (General) Rules, 2016 before you are allowed to resume duty.
 - (b) When reporting for duty, you should bring with your academic qualifications, caste and category certificates in original alongwith two sets of attested Photostat copies.
 - (c) Declaration of your having one spouse and in the event of your having more than one spouse living, the appointment will be subject to your being exempted from enforcement of the requirement of rules in this behalf.
 - (d) You will have to deposit a security of Rs. 1000/- (Rupees One Thousand only) (Rupees 500/- immediately, before joining the post and balance of Rupees 500/- in monthly installment of not less than Rupees 25/- till the security is deposited in full). Further, you will have to fill up a surety bond of Rs. 5000/- (Rupees Five Thousand only).
- (xiii) Sh. Girish Chander Pant S/o Sh. Mahesh Pant and Sh. Rinku Kumar S/o Sh. Krishan Kumar are already working in this Department as Sub-Inspector. Hence, they will be treated as technically resigned from the post of Sub-Inspector on the date they are relieved from the duties of Sub-Inspector. However, they will not be entitled for benefit of their past service towards seniority and their seniority will be fixed as per rules/instructions.
- (xiv) Sh. Girish Chander Pant S/o Sh. Mahesh Pant and Sh. Rinku Kumar S/o Sh. Krishan Kumar will not be required to undergo medical examination for 1st entry into Govt. Service as per Rule 15 of Haryana Civil Services (General) Rules, 2016, if they have already been issued certificate of fitness at the time of joining duties as Sub-Inspector. Further, if the verification of their documents from issuing authorities and antecedents of their character has already been done then no need to get their re-verification, however, if the same is not got done then it may be now got done as in the case of other candidates.
- (xv) Sh. Girish Chander Pant S/o Sh. Mahesh Pant and Sh. Rinku Kumar S/o Sh. Krishan Kumar will not be required to undergo training again, if they have already undergone the same at the time of their appointment as Sub-Inspector.

If you are willing to accept this offer of appointment on the terms and conditions mentioned above, you should report for duty to the concerned Distt. Food & Supplies Controller as mentioned against your name in the enclosed 'Annexure-A', within 30 days from the receipt of this offer failing which this offer will be treated as cancelled.
