ORDER

Sh. Jagbir Singh (Employee Code CD0L80) working as Auditor at the Directorate of Food, Civil Supplies & Consumer Affairs Department, Haryana, Chandigarh had made request for change of his cadre from Directorate Office to Sub-Offices due to his personal/domestic circumstances by giving relaxation in the educational qualification under the Haryana Food & Supplies Department Sub-Offices (Group-C) Service Rules, 1982. He has also submitted an undertaking stating therein that he will not claim the seniority of his past service rendered at the Directorate and he will also not claim his lien at the Directorate in future.

- Keeping in view his request, the matter regarding change of his cadre from Directorate Office to Sub-Office by giving relaxation in education qualification has been granted by the Competent Authority and he is hereby allowed to join Sub-Office by changing his cadre from Directorate Office to Sub-Offices and posted in the office of District Food & Supplies Controller, **Sonepat** against the vacant post of Auditor.
- The seniority of above official will be fixed below all the Auditors who are already working in Sub-Offices. However, his pay will be protected accordingly as per Haryana Government instructions/rules.
- It is made clear that his services will henceforth be governed under the Haryana Food & Supplies Department Sub-Offices (Group-C) Service Rules, 1982 from the date of his appointment by transfer in the above mentioned Sub-Office and accordingly he will be treated as junior most in the cadre of Auditors presently working in Sub-Offices.
- It is further made clear that he ceased to have any right/claim in the seniority and lien and/or other benefits for the service rendered at the Directorate.
- It is also made clear that after the change of cadre from Directorate Office to Sub-Offices, he will be liable to serve in any part of Haryana or any State Govt. office beyond the State Territories and he will also accept his posting anywhere in the State Government Offices.
- The other terms and conditions of his appointment will remain the same as already mentioned in the **Appointment letter issued to him vide this office letter Memo No. 34/1/07-5E(1)/2691, dated 17.02.2012 & promotion order issued vide Endst. No. 05/01/2014-5E(1)/21172 Dated 14.08.2014.**
- The official is hereby stand relieved from Headquarter **today i.e. 14.03.2022 (A.N.)** and directed to join his new place of posting immediately.
- No TA/DA will be paid to him for this.
