On the recommendations of the Haryana Staff Selection Commission, Panchkula vide letter No. HSSC-Confd/Recomm./2021/918, dated 30.12.2021. you are hereby offered an appointment to the post of Steno Typist (English) on provisional/temporary basis in the Field (Sub Office) of Food Civil Supplies and Consumer Affairs, Department, Haryana, in the pay band of Rs. 5200-20200+1900+100 Special Pay Grade Pay (pre-revised) Now (FPL-2 of Pay Matrix Table in the Haryana Civil Services (Revised Pay) Rules, 2016) plus usual allowances sanctioned by Haryana, Government from time-to-time and posted in the O/o District Food & Supplies Controller, Fatehabad on the following terms and

- This appointment is purely provisional/temporary and you will remain on probation for a period of two years which can be extended after taking into consideration your work and conduct to a total period not exceeding three years. Your services are liable to be terminated without notice on the abolition of the post or on the termination of vacancy or leave arrangement or any other arrangement against which you happened to be working at that time.
- If at any stage you desire to resign from your post in the Food, Civil Supplies & ii. Consumer Affairs Department, you will be required to give one month's clear notice or forfeit, in lieu thereof, one month salary including allowances or for the period by which the notice falls short of one month. Such a notice will be given to you by the department also in case it is proposed to terminate your service for the reasons other than that mentioned in Para-1 above. In case of misconduct or misbehavior, however, you will be given a reasonable opportunity to show cause as to why your services be not terminated, in that case the condition of one month's notice/salary will not apply.
  - As your character and antecedents have not been verified in terms of Government instructions issued vide memo No.52/3/20058-6S(I), dated 18th November, 2005 & subsequesnt State Govt. order dated 52/18/-3G-III, dated 10.01.2019, therefore, it is made clear to you that your appointment will remain provisional basis without prior verification of your character and antecedents. In case, subsequently any adverse fact come to the notice of this office regaeding your character and antecedents, your services are liable to be terminated immediately without anuy notice and without prejudice to such further action as may be taken under provision of the Indian Penal Code for production of false Certificates/ Statement/Attested copies. The Character & Antecedents will, however, be got verified within a period of two months after your provisional appointment and this relaxation does not confer any right to you to remain in job, if subsequently anything adverse is reported against you at a later stage.
- As the authenticity of your academic qualifications, caste and category certificates has iv. also not been verified/checked from the issuing authority, and the same are required to be got verified within a period of two months after your provisional appointment, therefore, it is made clear to you that if at any subsequent period, the same are found to be fake/false, your services are liable to be terminated and legal action will also be taken against you in this regard.
- Your services will be governed by the provisions contained in the Haryana Civil V. Services (General) Rules, 2016 and the Haryana Food, Civil Supplies & Consumer Affairs Department Sub-Offices (Group-C) Services Rules, 1982 as may be amended from time to time and also the Government instructions issued in this regard.
