2. The appointment/designation of S./Sh./Smt./ Dinesh Kumar, Hari Singh, Kiran Bala, Rao Virender and Satpal Malik is subject to the final outcome of disciplinary proceedings pending under Rule-7 of HCS (P&A) Rules against Sh. Rakesh Kumar, Auditor.

3. Sh. Suresh Chander, Auditor has requested that his cadre may not be changed till the final decision of CWP No. 21909 of 2013 titled as Raj Singh & others to be taken by the Hon'ble Punjab and Haryana High Court and hence did not opt for designation as Assistant. Similarly Sh. Ravinder and Sh. Charan Singh, Auditor have opted for promotion to the post of Accountant, therefore they are not considered for designation to the post of Assistant. Further, Sh. Dharampal, Auditor has requested that his name may not be considered for designation to the post of Assistant. Furthermore, Sh. Ramesh Malik, Auditor has not given any option in reference to Memo letter 3E(1)-2017/509/20278 dated 28.10.2021, despite the fact that it was made clear in the said letter that if no option is received within the stipulated period then it will be presumed that he is not interested for designation to the post of Assistant and the junior employees designated to the post of Assistant would become senior on the post of Assistant.

4. Hence, the above officials who are being presently designated as Assistant namely S./Sh./Smt. Dinesh Kumar, Hari Singh, Kiran Bala, Rao Virender and Satpal Malik would be senior to S./Sh. Suresh Chander, Ravinder, Charan Singh, Dharampal and Ramesh Malik on the post of Assistant as they have not opted for designation to the post of Assistant.

5. Had they not been appointed/designated to the post of Assistant they would have continued to officiate as Auditor.

6. On designation to the post of Assistant, they will continue to work at their present place of posting/seat.
