On the recommendations of the Haryana Staff Selection Commission, Panckhula vide Memo No. HSSC/ Confd.Recomm/2022/3341, dated 30.06.2022 sent in view of Hon'ble High Court Order dated 25.04.2022 in CWP No. 15672-2021 titled as "Amit Kumar & Ors. Versus State of Haryana & Ors (O&M), you are hereby offered an appointment to the post of Clerk on provisional/temporary basis in the Directorate of Food Civil Supplies and Consumer Affairs, Department, Haryana, Chandigarh (HQ.) in the pay band of Rs. 5200-20200+1900 Grade Pay (pre-revised) Now (FPL-2 of Pay Matrix

Table in the Haryana Civil Services (Revised Pay) Rules, 2016) plus usual allowances sanctioned by Haryana, Government from time-to-time on the following terms and conditions:-

- i. This appointment is purely provisional/temporary and you will remain on probation for a period of two years which can be extended after taking into consideration your work and conduct to a total period not exceeding three years. Your services are liable to be terminated without notice on the abolition of the post or on the termination of vacancy or leave arrangement or any other arrangement against which you happened to be working at that time.
- ii. If at any stage you desire to resign from your post in the Food, Civil Supplies & Consumer Affairs Department, you will be required to give one month's clear notice or forfeit, in lieu thereof, one month salary including allowances or for the period by which the notice falls short of one month. Such a notice will be given to you by the department also in case it is proposed to terminate your service for the reasons other than that mentioned in Para-1 above. In case of misconduct or misbehavior, however, you will be given a reasonable opportunity to show cause as to why your services be not terminated, in that case the condition of one month's notice/salary will not apply.
- As your character and antecedents have not been verified in terms of Government instructions issued vide memo No.52/8/2022-3GS-III, dated 23rd June, 2022 therefore, it is made clear to you that your appointment will remain provisional till the verification of your character and antecedents. In case, subsequently any adverse fact come to the notice of this office regarding your character and antecedents, your services are liable to be terminated immediately without any notice and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false Certificates/ Statement/Attested copies. The Character & Antecedents will, however, be got verified within the prescribed period as per instructions dated 23.06.2022 after your provisional appointment and this relaxation does not confer any right to you to remain in job, if subsequently anything adverse is reported against you at a later stage.

As the authenticity of your Academic Qualification, Age, caste/category certificates has also not been verified/checked from the issuing authority, and the same are required to be got verified after your provisional appointment, therefore, it is made clear to you that if at any subsequent period, the same are found to be fake/false, your services are liable to be terminated and legal action will also be taken against you in this regard.

- V. Your services will be governed by the provisions contained in the Haryana Civil Services (General) Rules, 2016 and the Haryana Food, Civil Supplies & Consumer Affairs Department Directorate (Group-C) Services Rules, 1982 as may be amended from time to time and also the Government instructions issued in this regard.
- Vi. Further, it is made clear to you that your services will be governed under the Finance Department Notification dated 28.10.2005, No. 1/1/2004-1 Pension (FD), dated 22.12.2005 & various provisions contained in Haryana Civil Services Rules, 2016 as amended from time to time and your services will be covered by the new defined contribution Pension Scheme as your fresh appointment is being made after 01.01.2006.
- Vii. You will have to qualify the State Eligibility Test in Computer Appreciation and Application (SETC) within the period of probation of two year extendable by one year, as per provisions of the Haryana Food, Civil Supplies & Consumer Affairs Department, Directorate (Group C) Service (Amendment) Rules, 2013.
- viii. It is also made clear to you that you will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies or examination.
 - ix. No T.A./D.A. will be granted for joining the post in the Department.
 - You are liable to serve in any place whether within or outside the State of Haryana or in the office of Central or other State Government or a company, an Association or a body of individuals whether incorporated or not, Municipal Corporation or local

authority or an international organization, an autonomous body not controlled by the Government or a private body.

- xi. You will have to give an undertaking in writing that if and when you enter any marital alliance, you shall strictly comply with anti dowry law, as amended from time to time, in letter and spirit and also furnish full details of all the articles of property and amount of money received by you from your in-laws in any name or manner, whatsoever. The undertaking shall be signed by your wife, father & father in law.
- xii. Your seniority will be fixed as per rules/instructions.
- You shall have to furnish a Medical fitness certificate from the Principal Medical Officer, Govt. In case you are already employed somewhere under the Haryana Govt. and you have already produced a medical certificate to the department, you may be exempted from producing fresh medical certificate provided, there is no break in your service and you will produce the Original Medical Fitness Certificate from your ex-employer within 15 days after your joining.
- xiv. Before assuming the charge of duties, you will be required to take the prescribed oath of allegiance to the Constitution of India and to produce the following certificates to the concerned District Food & Supplies Controller:

 - c) Relieving orders from your ex-employer, if you were already employed somewhere under the Haryana Govt.
