- 2. It is further made clear that promotion of above clerks is being made on their option, so after joining to the post of sub inspector, their lien on the post of clerk will be terminated automatically.
- 3. They will be on probation for a period of one year and will be governed under the Haryana Food & Supplies Department Sub Offices (Group-C) Service Rules, 1982.
- 4. It is certified that had they not been promoted to the post of sub Inspector they would have continued to officiate as Clerk.
- 5. They will have to deposit a security of Rs.500/ or more if later on so required. They will deposit lump sum of Rs.250/- immediately before joining the post and the remaining Rs 250/- in monthly installment not less than rs.12/- respectively till the security amount is completed. Further they will have to fill up a surety bond of Rs.5000/-
