ORDER

Whereas vide Orders dated 03.07.2013, issued under Endst.No.6E(i)-2013/19870, dated 03.07.2013, the work of Fumigation branch was assigned to the dealing Assistant of Storage Branch, who was looking after the work of damaged wheat being co-related to each other but presently the work of Fumigation seat is being looked after by Sh. Rajesh Bansal, District Food & Supplies Officer (HQ) with Sh. Yashpal Dalal, Deputy Superintendent and Sh. Manoj Kataria, Assistant, independently by taking out the same from the purview of Storage branch.

- Similarly, earlier the work of Legal Metrology used to be looked after by the Establishment-I Branch through Superintendent (Establishment-I) & Deputy/Joint/Additional Director (Administration) as the same is related to the Administrative Work of Legal Metrology but presently the work of Legal Metrology is being looked after by Ms. Rajbeer Kaur, District Food & Supplies Officer (HQ) with Smt. Bharati Gandhi, Deputy Superintendent and Sh. Vijay Kumar, Assistant, independently by taking out the same from the purview of Establishment-I branch.
- However, to streamline the work relating to Fumigation and Legal Metrology, it is hereby ordered that the work relating to Fumigation seat be looked after by the dealing Assistant of Storage Branch, who is looking after the work of damaged wheat through its respective channel i.e. Deputy Superintendent (Storage)/Deputy Director(Storage). Similarly, it is also ordered that the work relating to Legal Metrology be looked after by Establishment-I Branch through its respective channel i.e. Superintendent (Establishment-I), Joint/Additional Director (Administration).
- 4. Consequent upon the above orders, the work of Shortage and Recovery Branche is hereby assigned to Sh. Rajesh Bansal, District Food & Supplies Officer (HQ). Further, Sh. Vijay Kumar, Assistant,
