Dear Administrative Secretary,

As you are aware that the State is developing a **Block Parivartan Programme, Haryana** focusing on one underdeveloped block in each of its 22 districts. Efforts are being made to identify **one underdeveloped block per district** and the plausible Performance Indicators.

2. The Block Parivartan Programme will have **9 Key Performance Indicators (KPIs)** with **18 Pledges** in total. These 9 KPIs being Poverty Eradication, Infrastructure & Governance, Health & Nutrition, Education & Skilling, Equality & Empowerment, Water & Sanitation, Energy Management, Social Development, and Agriculture & Irrigation.

3. Over 100 indicators have been identified under these 9 KPIs, of which 18 are to be shortlisted. Thus, as the first step to drive this initiative, we are conducting a **brief presentation on the Block Parivartan Programme** to all related line departments where in the programme framework, identified indicators and expectations from the departments will be explained. Basis this the department will have to **identify the 5 most critical indicators with their validated data source in descending order in 7 working days**.
