ORDER

Sh. Aman Singh, Assistant Food Supplies Officer (5G3GJV) was transferred from Karnal to Cheeka District kaithal vide order dated 11.05.2022 issued under Endst. No. 6(E)1/142/2022/8559, dated 13.05.2022.

2. Against the above orders, Sh. Aman Singh, Assistant Food Supplies Officer filed a CWP No. 10913 of 2022 in the Hon'ble Punjab and Haryana High Court at Chandigarh. The Hon'ble High Court was pleased to pass the orders dated 20.05.2022 with the direction that "the petitioner to file a representation within two weeks and the same shall be decided by the competent authority keeping in mind what has been enumerated herein above and subject to verification thereof, appropriate orders be passed".

3. In coplinace of the above directions passed by Hon'ble High Court, Sh. Aman Singh submitted his representation dated 02.06.2022 in which he has stated that his both the daughters and son are studying in the schools situated in Karnal in 10th, 6th & KG, respectively. Furthermore, he also submitted that his wife is bed ridden and his 70 years old mother is also with him, who is suffering from various old age ailments and knee problem due to severe arthritis.

4. On consideration of the representation submitted by Sh. Aman Singh, a personal hearing was granted to him on 01.02.2023. Keeping in view the above and the averment made by him during personal hearing, the transfer orders of Sh. Aman Singh, Assistant Food Supplies Officer (5G3GJV) from Karnal to Cheeka District kaithal issued under Endst. No. 6(E)1/142/2022/8559, dated 13.05.2022 is hereby withdrawn.
