**ORDER**

**Sh. Kuldeep (Employee Code DH21T1)** working as Auditor in the O/o District Food & Supplies Controller, Hisar has made request for change of his cadre from Sub-Offices to Directorate Office due to his personal/domestic circumstances. Keeping in view of his domestic & family circumstances, the matter regarding change of his cadre from Sub-Office to Directorate Office has been decided by the Competent Authority and he is hereby allowed to join Directorate Office by transferring his cadre from Sub-Offices to Directorate and posted in the office of Directorate, Food Civil Supplies, & Consumer Affairs, Haryana against vacant post of Auditor.

2. It is made clear that his services will henceforth be governed under the Haryana Food Civil Supplies, & Consumer Affairs, Directorate (Group-C) Service Rules, 1982 and amendment there in from the date of his appointment by transfer in the Directorate Office and accordingly he will be treated as junior most in the cadre of Auditor presently working at Directorate.

3. The seniority of above official will be fixed below all the Auditors who are already working in Directorate. However, his pay will be protected accordingly as per Haryana Government Rules/instructions.

4. It is further made clear that he ceased to have any right/claim in the seniority and lien and/or other benefits for the service rendered in Sub-Office.

5. It is also made clear that after the change of cadre from Sub-Offices to Directorate Office, he will be liable to serve in any part of Haryana or any State Govt. office beyond the State Territories and he will also accept his posting anywhere in the State Government Offices.

6. The other terms and conditions of his appointment will remain the same as already mentioned in the **Appointment letter issued to him vide this office letter Memo No. 34/1/07-5E(i)/2686, dated 17.02.2012 & promotion order issued vide Endst. No. 3E(1)-Prom.Aud./2020/1473 Dated 25.01.2021.**

7. The official is directed to join his new place of posting immediately alongwith an undertaking stating therein that he will not claim the seniority of his past service rendered at Sub-Office and he will also not claim his lien in Sub-Office.

8. No TA/DA will be paid to him for this.
