The definitions of various terms that have been used in this document are as follows: "Service Provider" means an Indian registered firm/company which implements, integrates and shares its complete end-to-end software solution, application & data with customer's portals/applications for Vehicle Tracking Devices in India.

Retro Fitment Centre" means a firm/company to register VLTDs, support and service Vehicle Location Tracking Unit of all/different Service Providers.

1. Background

A VLTD (Vehicle Location Tracking and Monitoring) system is crucial for tracking trucks carrying foodgrains for several compelling reasons:

- Food Security: Ensuring a consistent and reliable supply of foodgrains is essential for food security, especially in a country with a large population. A VLTD system can help monitor the movement of foodgrains, ensuring they reach their intended destinations without theft, diversion, or spoilage.
- Traceability: The ability to trace the location and route of foodgrain-carrying trucks is vital for accountability. In case of any discrepancies or incidents, such as theft or accidents, the VLTD system provides a detailed record of the truck's journey, helping authorities investigate and resolve issues promptly.
- 3. **Preventing Theft and Pilferage**: Foodgrains are valuable commodities, making them susceptible to theft and pilferage during transportation. A VLTD system can deter theft by providing real-time tracking, making it challenging for unauthorized individuals to tamper with or steal foodgrains.
- 4. **Route Optimization**: VLTD systems can suggest the most efficient routes for foodgrain transportation, considering factors like road conditions and traffic.
- 5. Compliance with Government of India Regulations: VLTD systems will help in tracking of vehicles as directed by the Government of India regulations.
- 6. **Real-Time Monitoring**: It will lead to instant access to data about the location and condition of foodgrains in transit. This transparency enhances accountability and trust in the supply chain.

2. About Department of Food Civil Supplies and Consumer Affairs, Haryana.

"Haryana continues to enjoy the status of bread basket of India as it plays an important role in contributing a large part in the central food grain pool. Since its establishment in 1942, Department of Food Civil Supplies and Consumer Affairs, Government of Haryana continues to work to improve Public Distribution System, procurement process of food grains and their storage. In order to protect food grain from damage, the private entrepreneurs of Haryana have added enormous covered storage capacity under PEG scheme. The department is aiming at end to end computerization by creating a large database of all Arhtiyas, Mills and Mandis and for which the State Govt. has got developed a portal named ekharid portal for recording all activities relating to procurement of food grains.

About " Vehicle Tracking System"

Department of Food Civil Supplies and Consumer Affairs, Haryana envisages to track the vehicles used in transportation of food grains/ stock articles in the State of Haryana. The objective of the project is to introduce a vehicle tracking system for continuous monitoring of vehicles used in transportation of foodgrains in order to prevent recycling of PDS wheat / rice, bogus billing, transparent procurement, ensure benefit of MSP to farmers and better support to the enforcement services.

Components of Vehicle Tracking System

The tracking system is a combination of hardware, software and communication technologies. The major components of tracking system are:-

- 1. Vehicle Tracking Device (VTD): VTD is a hardware unit equipped with GPS/GNSS/IRNSS logger, a GPRS/3G/4G/5G based communication system, power supply and back up mechanism. The entire system is packed into a rigid enclosure with proper indications and power unit.
- 2. Vehicle Location Tracking System: A software system receives the data from VTD, passes it, logs it. This data is further processed for generating automated alerts and messages. The software resides in server(s).
- 3. Communication Facility: VTD sends the geo-location information to the server in a predefined interval. The most common communication method is using GPRS/3G/4G/5G, made possible through the existing mobile networks using SIM/eSIM.
- **4.** Monitoring System: A map system is integrated to the software for real time plotting of the vehicles on a map. Monitoring centres can view this map displayed on a web browser.

Technical Specifications

Technical Capability

- The Bidder must have a vehicle location tracking backend system tested and certified as per AIS-140 standard from a test agency prescribed in Central Motor Vehicle Rule (CMVR) 126.
- 2. Successfully Implementation/Integration of VTS (Vehicle Tracking System) in one similar project for at least 10,000 transport vehicles in last three financial years.

OR

Implementation/Integration of VTS (Vehicle Tracking System) in other similar projects with successfully handling experience of at least 15,000 (in total) transport vehicles in last three financial years.

3. The bidder must have at least 8-10 technically qualified IT professionals (relevant degree holders in B.Tech/BE/MCA/M.Tech/MBA) full time or permanent staff on company payroll working in the areas of software design and development, system integration (API/SFTP/etc.), IT infrastructure, operations and maintenance, GPS and GIS domain experts on rolls as per proposal due date. This team would coordinate with the departmental technical team for needful integration.

Certification requirements

The bidder must possess valid ISO 27001:2013/9000 certificate for information security management.

Application offered to be Security Audited by CERT-IN selected agencies and must have a valid safe to host certificate before bid submission date.

Scope of Work

The Service Provider shall facilitate the integration under (API) with all new & existing VLTDs

- The Service Provider shall ensure the integration in compliance with AIS-140:2016, as amended from time to time. The transport contractor will ensure that the VLTD devices (AIS-140) are functional in all the transport vehicles to be used for transportation of foodgrains procured by the procurement agencies.
- 2. The Service Provider shall ensure that the VTS should provide provision for the GIS based route maps which would be required for real-time vehicle tracking. Vehicle tracking, application software including complete Haryana Map, All India Map, Map engine and APIs all should be License Version. (On letter head and certificate if any)
 - i) GIS based road maps for VTS would be required to be provided by the bidder from available sources with proper licenses, etc. as may be required.
 - ii) Map resolution shall be at least 1:10,000 for major cities and 1:25,000 for the other places.
 - iii) Service Provider shall be required to create GPS based route maps for trucks on the procured road maps through route survey for specific time intervals. These route base maps should contain all traffic-able routes along with sufficient points of identification for easy identification of the exact location of the trucks.
- 3. The Service Provider shall ensure that the information elements that need to be captured and transmitted to e-Kharid portal at the minimum include longitude, latitude and physical location en-route with date and time stamps, truck number, distance covered & speed, map thumbnail snapshot in JPEG or PDF or any standard format, etc. The data shall be archived after 12 months/till season last (KMS 2023-24) [Department's Call regarding data archived 12 or more months].
- 4. The Service Provider shall ensure that Vehicle tracking Device shall provide these data on real time basis at pre-determined and configurable intervals (10 seconds) over best available network to support real time transfer of data (GPRS/3G/4G/5G network).
- 5. The Service Provider shall ensure that the VTS device should send alerts in case there is an attempt to tamper with the device and same shall be captured in Service Provider database (DB) along with other parameters of VLTD. Information regarding tampering shall be immediately sent to concerned agency(ies) head for necessary action on the transporter.

- 6. The Service Provider shall ensure that the data should be received even in case of vehicle operating in covered area or an environment which may not have a clear view of the sky. In such case, the Service Provider shall fetch data directly from saved data in VLTD.
- 7. The Service Provider shall ensure the facility for polling for current information location on demand (ensure real-time syncing).
- 8. The Service Provider shall facilitate the Vehicle Tracking System (VTS) which shall be able to compare the actual location of the truck, at any given time, with its scheduled location.
- 9. The Service Provider shall facilitate the VTS system to calculate the time for the truck to reach the destination, factoring in the current truck location and any deviations from the schedule and reported traffic congestion en-route.
- 10. The Service Provider shall ensure that the tracking of trucks that deviate from the scheduled route based on definition of permitted geographic regions of operation. In such cases, Service Provider to provide solution to report genuine case(s).
- 11. The Service Provider shall ensure that exception Recording/Actions (Over-Speeding, Off-route Detection) of all trucks operate under all agencies of FCS&CA Dept.
- 12. The Service Provider shall ensure that Vehicle tracking system is required to be functional 24 X 7 X 365 days. Vendor shall provide adequate resources.
- 13. The Service Provider shall ensure that it has capability of handling twice the data (future consideration/ expansion) in it's Data center.
- 14. The Service Provider shall ensure to have at least one office in tricity or Haryana manned by its own staff within fifteen days of award of letter of intent (LoI).
- 15. The Service Provider shall along with DFSC/ DMs from transporter ensure that installed VLTD devices should have activated SIM/eSIM network connection for at least for one year and must take necessary steps to ensure the continuity of the service once the SIM/eSIM validity period is expired. The prior alerts should be sent to transport contractor before expiry of the validity.
- 16. The Service Provider shall deploy suitable resources centrally and must have an operational call centre to address the queries. Proper log of such calls/ tickets to be maintained. The Service Provider may have to depute resources on field, on case to case basis, in case a special need arises. Any complaint/ ticket registered through the Service Provider's complaint redressal portal/Department website/email should be serviced within 48 hours. 4. State Command Control Centre (eKharid Portal) at DFSCs/DMs

State Command Control Centre (eKharid Portal) / backend application will be as per the requirement for effective monitoring of transportation of foodgrains. The following mandatory provisions will have to be made in the eKharid Portal/backend application:

- Registration and activation of the device(s) fitted, date of fitment & activation on the vehicle, including the details of vehicle registration number, engine number, chassis number, vehicle make and model, device make and model, and telecom service provider's name.
- Re-registration/re-activation of the device(s) fitted on the vehicle in case of any change in device or telecom service provider, etc.
- 3) Regular health check of the device(s) fitted on the vehicle.
- 4) Administration/configuration of devices for any changes in the parameters as decided by the Department from time to time.
- 5) Notification of alerts in case of defined deviations by vehicle such as over-speeding, deviation from defined route/geographic area, time of operation, etc.
