## **ORDER**

Smt. Suman Sharma (Employee Code TJAELO) working as Auditor at Directorate of Food, Civil Supplies & Consumer Affairs Department, Haryana, Chandigarh has made a request for change of her cadre from Directorate Office to Sub-Office. The matter regarding change of her cadre from Directorate Office to Sub-Office has been decided by the Comptetent Authority and she is hereby allowed to join Sub-Office by transferring her cadre from Directorate Office to Sub-Office and posted in the office of District Food & Supplies Controller, Karnal against vacant post of Auditor.

- 2. The official is hereby stand relieved from Headquarter today i.e. 22.09.2023 (A.N.) and directed to join her new place of posting immediately alongwith an undertaking stating therein that she will not claim the seniority of her past service rendered at Directorate and she will also not claim her lien in the Directorate of Food, Civil Supplies & Consumer Affairs Department, Haryana, Chandigarh.
- 8. No TA/DA will be paid to her for this.
