Subject:- "Just-in-Time" release of centrally sponsored Schemes (CSS) funds through e-Kuber platform of Reserve Bank of India(RBI)-SNA SPARSH - Opening Bank Account with RBI.

With reference to the orders of W/DFS on prepage i.e. pl. discuss with JCFA and then put up.

In this regard, it is submitted that JCFA, HQ has intimated that a meeting was held in Finance department on 09.07.2024 regarding onboarding of CSS on SNA SPARSH platform. It was directed by FD that concerned department shall open component wise and sharing ratio wise drawing accounts for State Linked Scheme (SLS) in RBI after consultation with concerned Ministry of GoI. The accounts will be opened after approval of Finance Department and Accountant General, Haryana and shall be operated by the DDO through cyber Treasury. Therefore necessary steps for opening Bank account with RBI may be initiated after consultation with DFPD.

Further, JCFA, HQ has also consulted, telephonically, in the Ministry of GoI i.e. DFPD and it was confirmed that the RBI Bank Account for NESA/PMGKAY-Handling & Transportation Charges and FPS Margin and Additional Margin has to be opened in RBI for onboarding of CSS on SNA-SPARSH platform.

In view of the letter received from JCFA, HQ and consultation with DFPD, file is submitted for deputing Nodal-Officer for SNA-SPARSH and approval for the opening of RBI Accounts for the payment of NESA/PMGKAY-Handling & Transportation Charges and FPS Margin and Additional Margin please so that the same may be provided to the Finance Department, Haryana.
