1. Background

VTS is crucial for tracking trucks carrying foodgrains for several compelling reasons:

- i. Food Security: Ensuring a consistent and reliable supply of foodgrains is essential for food security, especially in a country with a large population. VTS can help in monitoring the movement of foodgrains, ensuring they reach their intended destinations without theft, diversion, or spoilage.
- ii. Traceability: The ability to trace the location and route of foodgrain-carrying trucks is vital for accountability. In case of any discrepancies or incidents, such as theft or accidents, the VTS provides a detailed record of the truck's journey, helping authorities investigate and resolve issues promptly.
- iii. **Preventing Theft and Pilferage**: Foodgrains are valuable commodities, making them susceptible to theft and pilferage during transportation. A VTS can deter theft by providing real-time tracking, making it challenging for unauthorized individuals to tamper with or steal foodgrains.

- iv. **Route Optimization**: VTS can suggest the most efficient routes for foodgrain transportation, considering factors like road conditions and traffic.
- v. Compliance with Government of India Regulations: VTS will help in tracking of vehicles as directed by the Government of India regulations.
- vi. **Real-Time Monitoring**: It will lead to instant access to data about the location and condition of foodgrains in transit. This transparency enhances accountability and trust in the supply chain.
- 2. About Department of Food, Civil Supplies and Consumer Affairs, Haryana: The Department of Food, Civil Supplies and Consumer Affairs, Government of Haryana procures food grains under the Minimum Support Price (MSP) Scheme of the Government of India. Then it ensures proper storage with a view to upkeep the health of procured food grains till these are delivered to Food Corporation of India (FCI). It further enforces National Food Security Act, 2013 and operationalise the Public Distribution System (PDS) with special emphasis on Below Poverty Line (BPL), including Antodya Anna Yojna (AAY) Ration Card Holders.
- 3. About VTS: Department of Food, Civil Supplies and Consumer Affairs, Haryana envisages to track the vehicles used in transportation of food grains/stock articles in the State of Haryana. The objective of the project is to introduce a vehicle tracking system for continuous monitoring of vehicles used in transportation of foodgrains in order to prevent recycling of PDS wheat / rice, bogus billing, transparent procurement, ensure benefit of MSP to farmers and better support to the enforcement services. A vehicle tracking system combines the use of automatic vehicle location in individual vehicles with software that collects these fleet data for a comprehensive picture of vehicle locations. Its various components are:
 - 1. <u>Vehicle Location Tracking Device (VLTD):</u> VLTD is a hardware unit equipped with GPS/GNSS/IRNSS logger, a GPRS/3G/4G/5G based communication system, power supply and back up mechanism. The entire system is packed into a rigid enclosure with proper indications and power unit which is fitted in the vehicle. **VLTD should be an AIS-140 compliant device.**
 - 2. <u>Communication Facility:</u> VLTD sends the geo-location information to the server in a predefined interval. The most common communication method is using GPRS/3G/4G/5G, made possible through the existing mobile networks using SIM/eSIM.
 - 3. <u>Vehicle Tracking System (VTS):</u> A common back-end software system receives the data from various VLTDs, passes it and logs it. This data is further processed for vehicle tracking, generating automated alerts and messages. The software resides in server(s).
 - **4.** <u>Monitoring System:</u> A map system is integrated with the **back-end** software for real time plotting of the vehicles on a map. Monitoring centres can view this map displayed on a web browser.
- **4. Scope of Work:** The Service Provider shall facilitate the integration of all new & existing VLTDs (already installed by the transporters/millers) in order to ensure live-tracking of vehicles during the KMS (Kharif Marketing Season) and RMS (Rabi Marketing Season) on a single

platform/dashboard/module/application. For Kharif Marketing Season, the scope of work would include, but not limited to, live-tracking of vehicles from Mandi to Mill premises and from Mill to FCI Depot. For Rabi Marketing Season, the scope of work would include, but not limited to, live-tracking of vehicles from Mandi to FCI Depot/Godowns. The various responsibilities of Service Provider are:

- The Service Provider shall ensure the integration in compliance with AIS-140:2016, as amended
 from time to time. The transport contractor will ensure that the VLTDs (AIS-140) are functional
 in all the transport vehicles to be used for transportation of foodgrains procured by the
 procurement agencies.
- The Service Provider shall ensure that the VTS should provide provision for the GIS based route
 maps which would be required for real-time vehicle tracking. The application software must
 include complete Haryana Map, All India Map, Map engine and APIs all should be Licensed
 Version.
 - i) GIS based road maps for VTS would be required to be provided by the bidder from available sources with proper licenses, etc. as may be required.
 - ii) Map resolution shall be at least 1:10,000 for major cities and 1:25,000 for the other places.
 - iii) Service Provider shall be required to create GPS based route maps for trucks on the procured road maps through route survey for specific time intervals. These route base maps should contain all traffic-able routes along with sufficient points of identification for easy identification of the exact location of the trucks.
- 3. The Service Provider shall ensure that the information elements that need to be captured and transmitted to State Procurement portal must include longitude, latitude and physical location enroute with date and time stamps, truck number, distance covered & speed, map thumbnail snapshot in JPEG or PDF or any standard format, etc. The data shall be archived for 12 months for every vehicle.
- 4. The Service Provider is responsible for ensuring that data from all registered VLTDs in its VTS is captured in real-time. If at all there are any data issues, the VTS will promptly send alerts to District Field Officers and transporters/Millers.

The service provider is required to ensure that the data feed supplied to State Procurement Portal is configurable and can be provided to State Procurement Portal in real-time as well as upon specific requests. For example, the server provider's Vehicle Tracking System (VTS) captures data at 3-second intervals, but when providing it to State Procurement Portal, the interval can be adjusted as needed, preferably being set to 10 seconds or any other suitable duration as per requirements.

- 5. The Service Provider shall ensure that the VTS should send alerts in case there is an attempt to tamper with the VLTDs and the same shall be captured in Service Provider database along with other parameters of VLTD. The information regarding tampering shall be immediately sent to concerned agency head for necessary action on the transporter/miller.
- 6. The Service Provider shall ensure that the data should be received even in case of vehicle operating in covered area or an environment which may not have a clear view of the sky. In such

- case, the Service Provider shall fetch data directly from saved data of VLTD with the help of Transporter/Miller, VLTD Manufacturer and its associated software.
- 7. The Service Provider shall ensure the facility for polling for current information location on demand (ensure real-time syncing).
- 8. The Service Provider shall facilitate the Vehicle Tracking System (VTS) which shall be able to compare the actual location of the truck, at any given time, with its scheduled location.
- 9. The Service Provider shall facilitate the VTS to calculate the time for the truck to reach the destination, factoring in the current truck location and any deviations from the schedule and reported traffic congestion en-route.
- 10. The Service Provider shall ensure that the tracking of trucks that deviate from the scheduled route based on definition of permitted geographic regions of operation.
- 11. The Service Provider shall ensure that exception Recording/Actions (Over-Speeding, Off-route Detection) of all trucks operate under all agencies of FCS&CA Deptt.
- 12. The Service Provider shall ensure that VTS is required to be functional 24 X 7 X 365 days. Vendor shall provide adequate resources.
- 13. The Service Provider shall ensure that it has capability to handle twice the data (future consideration/expansion) in its Data center.
- 14. The Service Provider shall ensure to have at least one help desk/call centre in Tricity and 2 help desk /call centres in Haryana manned by its own staff within seven working days of award of Work Order.
- 15. At the time of registration, the Service Provider in coordination with DFSCs/ DMs of the concerned procuring agencies will ensure from the transporters/millers that installed VLTD should have activated SIM/eSIM network connection for at least one year. The prior alerts should be sent to the transport contractor before expiry of the validity.
- 16. The Service Provider shall deploy suitable resources centrally and must have an operational call centre to address the queries. Proper log of such calls/ tickets to be maintained. The Service Provider may have to depute resources on field, on case to case basis, in case a special need arises. Any complaint/ ticket registered through the Service Provider's complaint Redressal Portal/Department's website/Email should be serviced within 48 hours. Penalty of Rs. 500/- per day shall be imposed if the complaint is not resolved within 48 hours.
- 17. The Service Provider is also required to provide Escalation matrix on specific cases for Department Level Coordination and provide monthly reporting to Department.
- 18. The Service Provider shall provide mobile app/software for integrating VLTDs on the spot.
- 19. The Service Provider should have sufficient infrastructure like computer, internet service, official phone number, and technicians etc. to provide assistance to end users at the fitment/call/service centre.
- 20. The Service Provider will train the transporters/millers in coordination with DFSCs/DMs for integrating the VLTDs (AIS-140) on its back-end platform/application/VTS.

- 21. Further, the service provider shall ensure the enlisting, activation, regular check-ups and alert updates of VLTDs in coordination with the transporters/millers.
- 22. The Service Provider App/back-end portal will provide interface so that the Department is able to create Routes with route/point fencing so that the Department receives alerts and reports in case the vehicles deviates from its routes or in case of non-serving of their respective routes.
- 23. The Service Provider must send all types of alerts as required by the Department.
- 24. The Service Provider must ensure Integrity, Security, Non-tampering of data. The data must reside only on servers on the Indian soil. If any breach is found, the Service Provider will be liable for legal action by the department.
- 25. The Service Provider shall ensure the integration of all types of VLT devices (AIS-140) of any make / different OEMs with his solution/application.
- 26. The Service Provider shall provide that API service to state/center owned portals for providing the vehicle tracking data as and when requested.
- 27. The Service Provider will also create district wise dashboards (for DFSCs/ DMs) for live-tracking of any vehicle in that particular district for e.g. DFSC/DM Ambala shall be able to track all vehicles registered in Ambala on the Portal/Dashboard/Platform. The Service Provider shall also create Login-Credentials at the Head Office Level in order to monitor any vehicle in the whole of Haryana. The portal/dashboard must also have the provision to show GIS data to transporters/millers having their vehicles on boarded in the system along with reports.
- 28. The Service Provider must comply with all the technical requirements of the State Procurement Portal defined in this document or given from time to time in future, based on the requirements of the departments.
- 29. The Service Provider in coordination with DFSCs/DMs must have access to live Vahan portal/data for validating the mapping of Vehicle Number with IMEI of VLTDs installed in the vehicle.
- 30. The Service Provider shall ensure that exception Recording/Actions (Over-Speeding, Off-route Detection) of all trucks operate under all agencies of FCS&CA Deptt.
- 31. The mandatory provisions for the back-end application/ platform/App/VTS are as following:
 - i. The selected Service Provider in coordination with DFSCs/ DMs of the concerned procuring agencies shall register the VLTDs with the help of transporters/millers on their Portal/Dashboard/Application/VTS at the earliest after the issuance of the Work Order.
 - ii. Registration and activation of the device(s) fitted, date of fitment & activation on the vehicle, including the details of vehicle registration number, engine number, chasis number, vehicle make and model, device make and model, and telecom service provider's name.
 - iii. Re-registration/re-activation of the device(s) fitted on the vehicle in case of any change in device or telecom service provider, etc.
 - iv. Regular health check of the device(s) fitted on the vehicle.

- v. Administration/configuration of devices for any changes in the parameters as decided by the Department from time to time.
- vi. Notification of alerts in case of defined deviations by vehicle such as over-speeding, deviation from defined route/geographic area, time of operation, etc.
- vii. Location tracking of the vehicle including real-time as well as history tracking for upto last twelve months.
- viii. Notification through SMS in case any device(s) stops functioning.
- ix. Reports of the vehicles with devices not working/sending data beyond defined number of days (e.g. 1 day, 3 days, 7 days, 30 days or configurable by Department) are to be shared.
- x. Ensure that the security and privacy of the data is maintained in accordance with applicable laws/guidelines of various government authorities.
- 32. The Service Provider shall customize the platform/application/module/Mobile App as per directions of Director, Department of Food, Civil Supplies & Consumer Affairs and Project Head, State Procurement Portal, without any extra cost.

7. General Terms and Conditions:

- 1. The document for selection will be available on website (www.etenders.hry.nic.in) and can be downloaded and used for submission of application forms. Application fee shall be paid to the Department along with the submission of application.
- 2. It is mandatory for the applicant to submit all required documents or any other as desired by Department; otherwise his application will not be accepted. An unsigned and unsealed application shall not be accepted. All pages of the application and documents being submitted must be signed and sequentially numbered by the service provider. Ambiguous applications will be out-rightly rejected. Applications not submitted as per the format will be rejected straight away. Further, no deviations from the specifications will be accepted.
- 3. The service provider will bear all costs associated with the preparation and submission of their applications. Department will not be responsible or liable for those costs, regardless of the outcome of the selection process. Department may, at its own discretion, can add or delete any clause of this document.
- **4. The bidder shall be disqualified if the solution is found inappropriate or has variations from the actual Scope of Work.
- iv. If the bidder fulfills the criteria mentioned in point 7(8(i)), 7(8(ii)) and point 7(8(iii)) then the bidder will become eligible for the opening of Financial Bid. L1 bidder will be selected and negotiation of the quoted rate would be done as per Directorate of Supplies & Disposal, Govt. of Haryana Notification No. 2/2/2010-4-IB-II dated 16th June 2014 and Finance Department, Haryana letter no.14/26/2023&6FA, dated 10.05.2023 and in case, Committee considers that the negotiated rates are not reasonable/ competitive/ workable the Committee may consider cancelling and re-inviting the tenders.

The following provision has been made as per instructions of Finance Department, Haryana letter no. 14/26/2023&6FA,dated 10.05.2023:-

However, negotiation could be held upto four number of such bidder(s), in addition to L1 bidder in cases where there are bidders falling within 5% of the L1 bidder. In cases where the L1 bidder refuses to further reduce his offered price and any of the four bidders come forward to offer a price which is better than the price offered by L1 bidder, whose price is accepted becomes the L1 bidder.

However, in such a situation, the original L1 bidder may be given one more opportunity to improve upon the discovered price. In case, the original L1 bidder further improve upon the price discovered during the negotiations, he would be

treated as the L1bidder.

14. Blacklisting:
