ORDER

Sh. Shamsher Singh S/o of Sh. Achhar Singh, Inspector Food and Supplies (7A21D3) O/o District Food & Supplies Controller, Jind was due for retirement on superannuation on attaining the age of 58 years on 30.09.2024. The official has filed CWP No. 23480 of 2024 in the Hon'ble Punjab and Haryana High Court for retainment in service beyond 58 years being disabled employee. The official was allowed to continue his service after 30.09.2024 vide order dated 11.11.2024 in the CWP No. 23480 of 2024, which is as under:-

"In pursuance to the order of this Court dated 28.10.2024 a report dated 09.11.2024 from the Medical Board constituted by the PGIMER, Chandigarh has been produced in a sealed cover which, after opening the seals, is perused and taken on record.

As per the afore referred report of PGIMER, Chandigarh the petitioner is visually handicapped by 40% and has 25.43% hearing impairment.

Learned counsel for the petitioner inter alia relies on the issuance of notice and grant of interim relief in a similar matter being CWP No.6460 of 2023 - Dilbag Singh Vs. State of Haryana and others.

Notice of motion.

Ms. Shruti Jain Goel, Senior DAG, Haryana accepts notice on behalf of the respondents and prays for time

to file a written statement.

2. The case filed by the official was clubbed with main case CWP No. 2340 of 2023 titled as Jora Singh Vs State of Haryana and others. The Hon'ble Punjab and Haryana High Court passed final order on 06.11.2025 in the CWP 2340 of 2023. The Operative part of the order dated 06.11.2025 in CWP No. 2340 of 2023 is as under:-

"In such circumstances, while deciding these matter(s), we deem it appropriate to clarify that it shall be open for the State of Haryana to take a conscious decision whether or not to allow the extended age of superannuation for persons suffering with disability, in light of the provisions contained in the Act of 1995 as also the Act of 2016."

In Compliance of the above orders, Finance Department, Haryana has issued the notification dated 03.02.2026 and letter No. 11/58/2023-1FR/2714 dated 03.02.2026 omitted the Sub-rule (1), clause (i), clause (ii), Note 1 and Note 3 of Rule 143 of Haryana Civil Services (General) Rules, 2016 which leads to disentitle the official to serve beyond the age of superannuation i.e 58 years. Therefore, the official shall retire from Government Service with immediate effect in terms of Haryana Civil Service (General Rule)-2016 Sub-Rule-143 as amended from time to time.

3. His retirement order is subject to the final outcome of the disciplinary proceedings pending against him under Rule-7 issued vide Memorandum No. 3E(111)-2018/21086-87, dated 27.09.2018 of Haryana Civil Service (Punishment and Appeal) Rules, 2016 and FIR No. 806, dated 10.07.2017 pending against him in District & Session Court, Sirsa.

4. His retirement order is also subject to any liability/recovery which may come to the notice of the department at any later stage after his retirement.
