ORDER

Sh. Satyawan S/o of Sh. Chander Bhan, Inspector Food and Supplies (CB3GE7) O/o District Food & Supplies Controller, Rohtak was due for retirement on superannuation on attaining the age of 58 years on 31.05.2025. The official has filed CWP No. 12713 of 2025 in the Hon'ble High Court of Punjab and Haryana for retainment in service beyond 58 years being disabled employee. The official was allowed to continue his service after 31.05.2025 vide Hon'ble High Court interim order dated 06.05.2025 in the CWP No. 12713 of 2025, which is as under:-

"Learned counsel for the petitioner relies upon the order dated 27.02.2023 passed by the Co-ordinate Bench in CWP No. 2340 of 2023 titled as 'Jora Singh Vs State of Haryana and others' which was passed in terms of the judgement in 'Hardev kaur Vs State of Haryana and Others', 2015(3) S.C.T 825.

Notice of motion returnable for 22.05.2025.

In the meanwhile, the respondents are directed to permit the petitioner to continue perform his duties till he attains the age of 60 years"

2. The case filed by the official was clubbed with main case CWP No. 2340 of 2023 titled as Jora Singh Vs State of Haryana and others. The Hon'ble High Court passed final order on 06.11.2025 in the CWP 2340 of 2023. The Operative part of the order dated 06.11.2025 in CWP No. 2340 of 2023 is as under:-

"In such circumstances, while deciding these matter(s), we deem it appropriate to clarify that it shall be open for the State of Haryana to take a conscious decision whether or not to allow the extended age of superannuation for persons suffering with disability, in light of the provisions contained in the Act of 1995 as also the Act of 2016."

In Compliance of the above orders, Finance Department, Haryana has issued the notification dated 03.02.2026 and Letter No. 11/58/2023-1FR/2714 dated 03.02.2026 omitted the Sub-rule (1), clause (i), clause (ii), Note 1 and Note 3 of Rule 143 of Haryana Civil Services (General) Rules, 2016 which leads to disentitle the official to serve beyond the age of superannuation i.e 58 years. Therefore, the official shall retire from Government Service with immediate effect in terms of Haryana Civil Service (General Rule)-2016 Sub-Rule-143 as amended from time to time.

3. His retirement order is subject to the final outcome of the disciplinary proceedings pending against him under Rule-7 issued vide Memorandum No. 2E(III)-21/89/2019/3439, dated 06.03.2023, under Rule-8 issued vide Memorandum No. 3E(III)-2016/19725 dated 16.09.2016 and another case/Chargesheet of shortage of stock of Haryana Civil Service (Punishment and Appeal) Rules, 2016.

4. His retirement order is also subject to any liability/recovery which may come to the notice of the department at any later stage after his retirement.
