**ORDER**

Consequent upon Government Notification No. 11/58/2023-1FR/27758 dated 3<sup>rd</sup> February, 2026, and in pursuance thereof, the earlier order issued vide Endst. No.01/20/2024-1FS dated 30<sup>th</sup> October, 2024, in respect of Smt. Kiranjit Kaur Walla, Superintendent (H.Q.), Food, Civil Supplies and Consumer Affairs Department, regarding extension of the age of superannuation from 58 years to 60 years on the basis of 40 % physical disability in accordance with the interim order of Hon'ble High Court passed in CWP No. 28538 of 2024, is hereby revoked with effect from date of Gazette Notification. Accordingly, Smt. Kiranjit Kaur Walla, Superintendent, HQ shall be deemed to have retired from Government service with effect from 03.02.2026, i.e., the date of publication of the said Gazette Notification.

2. Further, the retirement of Smt. Kiranjit Kaur Walla, Superintendent, shall be subject to the condition that she shall be liable to make good any loss, if detected subsequently, which shall be recoverable in accordance with Rules 12 and 81(1) of the Haryana Civil Services (Pension) Rules, 2016. It shall also remain subject to the final decision to be taken in the disciplinary proceedings pending against her under Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016.

3. This order is, however, issued without prejudice to any claim of the State Government that may arise against her thereafter.


