ORDER

Whereas; Sh. Manoj Kumar, Inspector Food & Supplies (now Assistant Food & Supplies Officer) was ignored for promotion to the post of Assistant Food & Supplies Officer (AFSO) as FIR No. 806 dated 10.10.2017 was pending against him at that time and his junior, Sh. Jai Yadav, was promoted to AFSO vide Endst. No. 8E(i)-2018/7730 dated 13.04.2018. Thereafter, Sh. Manoj Kumar, Inspector Food & Supplies (now Assistant Food & Supplies Officer), had submitted a representation to seek deemed date of promotion to the post of Assistant Food & Supplies Officer (AFSO) from the date of promotion of his junior, Sh. Jai Yadav, AFSO.

2. Whereas; a report regarding the status of FIR No. 806 dated 10.10.2017 was obtained from the District Food & Supplies Controller, Sirsa. He had informed vide letter dated **27.05.2026**, that no challan has been presented by the Special Investigation Team (SIT) in the Court against Sh. Manoj Kumar.

3. Whereas; the chargesheet issued against Sh. Manoj Kumar, IFS (now AFSO) under Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, vide Memo dated **09.08.2018**, was dropped vide order dated **21.12.2022**. Further, another chargesheet issued under Rule 7, Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide Memo dated **27.09.2018** was also dropped vide order dated **25.03.2025**.

4. Therefore, keeping in view the fact that after investigation no challan has been presented by the police in the Court of law against Sh. Manoj Kumar and both chargesheets of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 have also been dropped; Sh. Manoj Kumar, IFS (Now AFSO), is entitled to the benefit of deemed date of promotion to the post of Assistant Food & Supplies Officer from the date on which his junior was promoted. Accordingly, in terms of Government instructions dated 18.11.1971, Sh. Manoj Kumar, Assistant Food & Supplies Officer is hereby granted the deemed date of promotion to the post of Assistant Food & Supplies Officer w.e.f. 13.04.2018, i.e. the date on which his junior, Sh. Jai Yadav was promoted. Consequent upon the grant of the deemed date of promotion, his position in the seniority list of AFSOs shall stand revised from Sr. No. 74 to Sr. No. 19.

5. The benefit of the deemed date of promotion shall be restricted to notional pay fixation and seniority only. No arrears of pay or any other actual monetary benefits shall be admissible for the period prior to his actual promotion.
