2. The appointment/designation of above officials is subject to the final outcome of disciplinary proceedings pending under Rule-7 of HCS (P&A) Rules against Sh. Rakesh Kumar, Auditor and Sh. Raman, Auditor, who are senior to the above mentioned Auditors.

3. Sh. Charan Singh, Auditor and Sh. Bijender, Auditor have opted for promotion to the post of Accountant, therefore, they have not been considered for appointment/designation to the post of Assistant. Furthermore, S/Sh. Dinesh, Ramesh Kumar, Arun Kumar, Gaurav Thakur, Gagandeep, Mohit Kumar and Devender, Auditors have also not given any option in reference to Memo letter 3E(1)-2026/12233 dated 14.07.2026, despite the fact that it was made clear in the said letter that if no option is received within the stipulated period, then it will be presumed that they are not interested for appointment to the post of Assistant and the junior employees shall be appointed to the post of Assistant and would become senior on the post of Assistant.

4. It is also pertinent to mention here that as per advice given by the Accounts Organization of the Department and Haryana Civil Services (Pay) Rules, 2016 "The benefits of one increment shall not be admissible on appointment from one post to another where the functional pay structure both the posts are same, and at present the pay structure of both the posts of Auditor and Assistant is also the same. In such cases, on appointment from one post to another, pay and date of increment shall remain unchanged.

5. Therefore, the above officials who are being presently appointed as Assistant namely S./Sh./Smt. Meenal Wahi, Shanti Devi, Anil Kumar and Kuldeep would be senior to S/Sh. Dinesh, Ramesh Kumar, Arun Kumar, Gaurav Thakur, Gagandeep, Mohit Kumar and Devender on the post of Assistant as the latter have not opted for appointment to the post of Assistant.

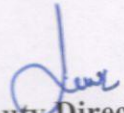
