ORDER

Whereas, Sh. Ravinder Jaglan ,(payee code 1F36PV),AFSO presentaly posted at Yamunanagar, was charge-sheeted in respect of his tenure at Karnal under Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide Memorandum No. **2E(III)-21/96/2019/2046 dated 03.02.2022**. The charges pertained to alleged irregularities in the distribution of ATTA under the Public Distribution System (PDS) by certain depot holders in District Karnal, under his control. The charges also includes his failure to conduct inspections/checking of depot holders and failure to ensure submission of utilization certificates relating to the sale/distribution of essential commodities by the depot holders under his jurisdiction.

And whereas, a regular departmental inquiry was entrusted to Sh. Surender Saini, DFSC (now Deputy Director), who submitted his Inquiry Report on **16.03.2023**. The Inquiry Officer concluded that the charges leveled against the charged official were **not proved**, observing that the matter related to the pilot project of ATTA distribution implemented during the relevant period and that the allegations could not be substantiated on the basis of the evidence available on record.

And whereas, the charged official was afforded an opportunity of personal hearing on **24.07.2026**, during which he submitted his defence. The submissions made by him have been duly considered along with the Inquiry Report and the entire record of the case.

After careful consideration of the material available on record (the charge-sheet, written statement of defence, Inquiry Report & submissions made during the personal hearing), It is found that inquiry officer has not proved the charges against the charged official and the reply of the charged official is stiasfactory, hence it would be appropriate to drop the disciplinary proceedings initiated against Sh. Ravinder Jaglan,AFSO vide Memorandum No. 2E(III)-21/96/2019/2046 dated 03.02.2022.

I, order accordingly.

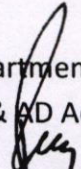
