post is available due to the reversion of any official from the post of Assistant Food & Supplies Officer, the repatriation of any official on deputation to the parent post of Inspector, or where any senior Sub-Inspector, whose case could not be considered due to the pendency of proceedings under Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, pending criminal proceedings, or any other reason, subsequently becomes eligible for promotion, the equivalent number of junior-most officials (Inspectors), will be reverted to the post of Sub-Inspector without any notice. The pay of the above officials shall be fixed on a notional basis with effect from the date on which they are deemed to have been promoted. However, the actual financial benefits and pay fixation shall accrue only from the date they assume charge of the post of Inspector, Food & Supplies.

2. The promotion of the above officials is also subject to any adverse remarks in pending ACRs.
3. They will be on probation for a period of one year and their services will be governed under the Haryana Food and Supplies Department Sub Office (Group-C) Service Rules, 1982.
4. It is certified that had they not been promoted to the post of Inspector Food & Supplies, they would have continued to officiate as Sub-Inspector Food & Supplies.
5. The orders regarding the places of posting of the above officials shall be issued separately.
