ORDER

Whereas; Sh. Rahul Kumar, Sub-Inspector, was charge-sheeted under Rule 8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, vide Memo No. 3E(III)-2020/14680 dated 27.08.2020, for the acts of omission and commission specified in the charge-sheet during his posting in the office of DFSC, Narnaul, particularly regarding failure to furnish the requisite information under the RTI Act despite repeated directions issued by the Circle Office (DFSC Narnaul) and Headquarters.

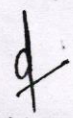
Whereas; the charge-sheet was issued on 27.08.2020 and six reminder letters were issued to the official directing him to submit his written statement of defence. However, no reply was received from him despite repeated opportunities. As per the provisions of Rule 8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, the charged official is required to submit his written statement of defence within 15 days from the date of receipt of the charge-sheet. More than five years had elapsed since the issuance of the charge-sheet, yet the official failed to submit his written statement of defence.

Whereas; an opportunity of personal hearing was granted to him on 05.08.2026 at 11:00 A.M. The official appeared for the personal hearing on the scheduled date and submitted his reply in respect of the charges.

After careful consideration of the material available on record (the charge-sheet, written statement & submissions made during the personal hearing), it is found that though the reply of the official is satisfactory but he has not replied to charges even after repeated reminders. This indicates indiscipline on his part. Hence, it would be appropriate that punishment of censure is imposed on the official for his conduct on account of delay in submitting reply to the charge-sheet issued to Sh. Rahul Kumar vide Memo No. 3E(III)-2020/14680 dated 27.08.2020.

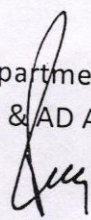
