ORDER

Whereas; Sh. Ramesh Kumar, Auditor (now Accountant), O/o District Food & Supplies Controller, Sirsa, was charge-sheeted under Rule 8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, vide Headquarters Memo No. **1E(III)-8/98/2019/1716 dated 29.01.2021**, for the acts of omission and commission specified in the charge-sheet during his posting in the office of District Food & Supplies Controller, Sirsa, particularly regarding his alleged failure to receive the summons issued by the Hon'ble Court, his alleged absence from office on 27.07.2019 and his alleged failure to submit the report relating to PR-58 within the prescribed time.

Whereas; the charged official submitted his written statement of defence on **22.07.2024**, which was forwarded to the District Food & Supplies Controller, Sirsa, for comments. However, as per comments received from the District Office, Sirsa only the reply regarding charge no. 1 & 2 were satisfactory.

Whereas; an opportunity of personal hearing was granted to him on 12.08.2026 at 11:00 A.M. The official appeared for the personal hearing on the scheduled date and submitted his reply in respect of the charges.

After careful consideration of the material available on record (the charge-sheet, written statement, comments of DFSC, Sirsa on the reply of the official & submissions made during the personal hearing), it is found that reply for charge no 1 is satisfactory and reply of charge no 2 is partially satisfactory. The charge no. 3 relates to the pendency of PR-58 on the seat of the charged official and the disposal of work. The official could not satisfactorily explain the pendency of PR-58 on his seat. Further, although he is presently looking after the work relating to Stock Accounts, he was also unable to explain the status of Stock Accounts for the year 2022-23. Accordingly, Charge No. 3 is proved against him. Hence, it would be appropriate that minor punishment of stoppage of four increments without cumulative effect is imposed on Sh. Ramesh Kumar, Auditor (now Accountant).
