ORDER

Sh. Shamsher Singh, son of Sh. Achhar Singh, Inspector, Food & Supplies, O/o District Food & Supplies Controller, Jind, was due to retire from Government service on attaining the age of 58 years on 30.09.2024 and he filed CWP No. 23480 of 2024 before the Hon'ble Punjab and Haryana High Court, seeking continuation in service beyond the age of 58 years on the ground of being a disabled employee. The Hon'ble High Court, vide order dated 11.11.2024, allowed him to continue in service beyond 30.09.2024.

2. The above case was clubbed with CWP No. 2340 of 2023 titled Jora Singh Vs. State of Haryana and others. The Hon'ble Punjab and Haryana High Court passed the final order in the main case on 06.11.2025. In compliance with the said order, the Finance Department, Haryana, issued Notification/Letter No. 11/58/2023-1FR/2714 dated 03.02.2026, whereby Sub-rule (1), clauses (i) and (ii), Note 1 and Note 3 of Rule 143 of the Haryana Civil Services (General) Rules, 2016 were omitted. As a result, the provision under which the official was continuing in service beyond the age of 58 years ceased to apply. Accordingly, Sh. Shamsher Singh was retired from Government service w.e.f. 17.02.2026 under Rule 143 of the Haryana Civil Services (General) Rules, 2016, as amended from time to time.

3. Aggrieved by the retirement order dated 17.02.2026, Sh. Shamsher Singh, IFS filed CWP No. 5980 of 2026 before the Hon'ble Punjab and Haryana High Court. The Hon'ble High Court, vide order dated 26.02.2026, stayed the retirement order dated 17.02.2026. In view of the order of the Hon'ble High Court, the retirement order dated 17.02.2026 was withdrawn vide this Department's order dated 20.03.2026 and the official was allowed to continue in Government service.

4. **Now, Sh. Shamsher Singh, IFS is attaining the age of 60 years on 30.09.2026. Accordingly, he shall retire from Government service on attaining the age of superannuation on 30.09.2026 (A/N).**

5. His retirement shall be subject to the final outcome of the disciplinary proceedings pending against him under Rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, initiated vide Memorandum No. 3E(111)-2018/21086-87 dated 27.09.2018, as well as the criminal proceedings arising out of FIR No. 806 dated 10.07.2017, pending before the Hon'ble Court.

6. His retirement shall also be subject to any Government dues, liability or recovery which may come to the notice of the Department at any stage after his retirement.
