ORDER OF THE GOVERNOR OF HARYANA

In exercise of the powers conferred under note 2 below rule 15.1 read with rule 2.14 of the Punjab Civil Services Rules, Volume-I, Part-I, as applicable to the State of Haryana, the Governor of Haryana is pleased to delegate all the powers available to the Administrative Secretary to Government, to the State Election Commissioner, Haryana in so far as the work relating to the State Election Commission, Haryana is concerned. - powers shall consult the State Finance Department on all such matters which were required to be referred to the Finance Department by the Administrative Secretary.

The above delegation is subject to the condition that State Election Commissioner shall exercise the delegated powers subject to overall authority of the State Government and expenditure as a result of exercise of the powers/no case shall exceed the sanctioned budget grant of the Commission and in accordance with the instructions issued by the State Government from time to time.
