NOTIFICATION

Dated, the 12th March, 2020

No. SEC/4E-II/2020/ 648: Whereas the State Election Commission vide its notification No. SEC/4E-II/2018/48, dated 11.01.2018 had prescribed the programme for the conduct of election to the seat of Sarpanch, Gram Panchayat Sumain, District Fatehabad according to which nomination papers were to be presented between 18.01.2018 to 24.01.2018 and the polling was scheduled to be held on 04.02.2018.

- 2. Whereas,in pursuance of orders dated 23.01.2018, passed by Hon'ble Punjab & Haryana High Court in CWP No. 1403 of 2018 Sonil Vs. State of Haryana & others, the Commission vide its notification dated 02.02.2018 ordered that "all activities on the notification referred above in respect of the election of Sarpanch, Gram Panchayat Sumain, Block Tohana, District Fatehabad scheduled for 04.02.2018 shall be kept in abeyance till further orders". Hon'ble High Court vide orders dated 13.02.2020 dismissed the writ petition referred above.
- 3. Now, the State Election Commission, Haryana in exercise of powers vested under clause (1) of Article 243K of the Constitution of India read with Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994, and all other powers enabling in this behalf hereby prescribe time schedule for the conduct of elections to the seat of Sarpanch, Gram Panchayat Sumain, Block Tohana, District Fatehabad as under:-
