- Whereas, as per order dated 13.08.2018 passed by the Additional Civil Judge 2. (Sr. Div.), Guhla in an election petition titled Birender Singh Vs. Vishpal and others, election of Vishpal @ Bishpal Singh son of Balbir Singh as Sarpanch of Gram Panchayat- Agondh has been set aside.
- memo vide Kaithal whereas, the Deputy Commissioner, 3. And No.9016/Panchayat, dated 06.12.2018, has informed that appeal filed by Sh. Bishpal Singh through CWP No. 21431 of 2018 titled as Vishpal versus State of Haryana and others in the Hon'ble Punjab and Haryana High Court has also been dismissed vide order dated 27.08.2018. He has also further informed that Sh. Bishpal Singh has filed SLP in the Hon'ble Supreme Court of India, but no any stay order has been granted by the Hon'ble Supreme Court of India.
