- 3. A copy of the plan for deployment of Executive Magistrates and police personnel be also sent to this Commission well in time.
- 4. Provide security to the contesting candidate, if they so desire.
- 5. It shall be ensured that no untoward incident takes place during the Panchayat General Election.
