ORDER

The General Elections of Zila Parishad, Faridabad were held on 10.01.2016 and the result of the elected candidates was declared on 28.01.2016.

2. As per provisions contained in the Haryana Panchyati Raj Election Expenditure (Maintenance and Submission of Accounts) Order, 1996, every candidate contesting election to the post of Member of Zila Parishad shall have to maintain day to day election expenditure account in accordance with the procedure laid down in paras 4, 5 and 6 of these orders and shall have to lodge his account of election expenses within 30 days from the date of declaration of result of the election in the prescribed format with the Deputy Commissioner-cum-District Election Officer(Panchayat) or any other officer as specified by the Commission. The total of the expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Para 11 of these orders provides that if the State Election Commission is satisfied that a person --

- (a) has failed to lodge an account of election expenses, within the time and in the manner required by or under this Act, and
- (b) has no good reason or justification for the failure the State Election Commission shall, by order published in the Official Gazettee, declare him to be disqualified and may such person shall be disqualified for a period of three years from the date of the order.

4. The Commission, vide its notification No. SEC/2E-II/2015/5782, dated 03.06.2015 prescribed the limit of expenditure of Rs. 2,00,000/- that may be incurred by the contesting candidate or his authorized agent in connection with election of Member Zila Parishad.

5. As reported by the Deputy Commissioner-cumDistrict Election Officer, Faridabad through his letter No. 1047/Panchayat, dated 15.06.2016 the following candidates had contested the election of Zila Parishad, Faridabad and failed to submit their election expenditure account within the prescribed time or thereafter:-

The Commission had served a show cause notice upon them to explain as to why they should not be disqualified on account of non submission of election expenditure account within the prescribed period. They neither submitted their election expenditure statement nor responded to the show cause notice. I, had given them personal hearing in my office chamber on 31.05.2017 in the interest of justice. Sh. Vikas Panchal, Gram Sachiv, represented the the Deputy Commissioner, Faridabad.

7. The above mentioned contesting candidates did neither appear before me nor filed any representation/reply. Therefore, it can be concluded that they have nothing to say in the matter. Hence, the above noted candidates deserve to be disqualified. I, Dr. Dalip Singh, State Election Commissioner, Haryana, in exercise of powers vested under Article 243 K of the Constitution of India and Section 212 of the Haryana Panchayati Raj Act, 1994 and all other powers enabling it in this behalf hereby order that all the above mentioned 30 candidates be disqualified for being chosen as, and for being a member of Panchayats i.e. Gram Panchayat, Panchayat Samiti and Zila

Parishad for a period of three years from the date of this order.

8. The office is directed to send a copy of this order to the candidates concerned through Deputy Commissioner-cum-District Election Officer, Faridabad immediately.

9. The office is further directed to host a copy of this order on website of the Commission.
