The State Election Commission, Haryana vide notification No. SEC/3E-II/2015/10233, dated 15th December, 2015 has issued the election programme for the conduct of elections of Panchayati Raj Institutions in the State of Haryana. In TABLE-D, para 5 of the notification, the names of the Gram Panchayats (including Gram Panchayat Sudhiwas mentioned at sr. no.2 column 4 of the table) where elections are not be held due to certain reasons like non completion of existing terms, wardbandi etc., are given.

2. District Election Officer (P), Bhiwani vide Memo No. 12458/Panchayat dated 25.12.2015 has submitted that the wardbandi of the Gram Panchayat Sudhiwas, Block Behal has been done afresh and final publication of the same has been made on 24.12.2015. The request has, therefore, been made to allow to conduct the election of the Gram Panchayat in the schedule of third phase elections.

3. In view of the request of the District Election Officer (Panchayat), Bhiwani, the Commission hereby exclude the name of Gram Panchayat Sudhiwas from TABLE-D (sr. no. 2 of column 4) of para 5 and further allows to conduct the election of the Gram Panchayat as per the schedule of phase 3rd of the notification under reference.

4. Rest of the conditions mentioned in the notification dated 15.12.2015 of this Commission shall remain unchanged.
