Other terms and conditions are proposed as under: -

- a) For Unforeseen Areas
 - 1) The aforesaid rates are only "Dry Leasing" charges and do not include POL expenditure. The POL expenditure was provided by the concerned CPMF in addition to the aforesaid hiring charges.
 - 2) Facilities of boarding and lodging to the crew staff were provided by the CPMF. However, the vehiclular staff paid a sum of Rs. 30/- per diet and free accommodation was also provided by the CPMF.
 - 3) It was agreed that the vehicular staff will be provided the same compensation in case of terrorist related violence as available to CPMF from the State of J&K.
 - 4) It was also agreed that in case of damage of vehicles due to terrorist related violence compensation to the vehicle owner would be paid as per the assessment of the damage by the Govt. of J&K>
 - 5) 50 % of the hiring charges was paid in advance.
 - 6) The vehicles shall be exempted from payment of inter-state taxes.
- b) For Peace Area
 - 1) Diesel and POL shall be supplied by the hirer.
 - 2) The above rates shall be inclusive of all taxes etc.,
 - 3) No payment shall be made for a now-working day when the vehicles are not in fit mechanical condition.
 - 4) Cost of major and minor repairs shall be borne by the owner.
 - 5) The owners shall provide their own drivers and cleaner/conductor who shall be responsible for the efficient and proper maintenance. Pay and other expenses of drivers/cleaners shall be borne by the owner.
 - 6) Cost of replacement of tyres and tubes shall be borne by the owners.
 - 7) Passenger and goods tax. If levied shall be borne by the hirer.
