Subject:- Polling Personnel and Police Officers & other officers shall be on deputation with the State Election Commission during the Municipal Corporation Byeelections.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of bye-election for the seat of ward No. 34 of Municipal Corporation, Gurugram and ward No. 7 of Municipal Corporation, Karnal vide Notification No. SEC/1ME/2021/3499 dated 10.09.2021 (copy enclosed). As per schedule, the nomination papers shall be presented **17.09.2021 to 22.09.2021** (except on 19.09.2021 being Sunday) and the poll shall be held on **03.10.2021**. Counting of votes shall be taken up after the close of poll in all the polling stations and the result shall be declared immediately after completion of counting.

2. As per Section 8D of the Haryana Municipal Corporation Act, 1994, the provisions given under Section 28A of the Representation of the Peoples Act, 1951 are to be mutatis mutandis applied in municipal elections. The provisions given under Section 28A of the Representation of the Peoples Act, 1951, are reproduced here as under:-

"28A. Returning officer, presiding officer, etc., deemed to be on deputation to Election Commission.- The Returning Officer, Assistant Returning Officer, Presiding Officer, Polling Officer and any other officer appointed under this part, and any Police Officer designated for the time being by the State Government, for the conduct of any election shall be deemed to be on deputation to the State Election Commission for the period commencing on and from the date of

notification calling for such election and ending with the date of declaration of the results of such election and accordingly, such officers shall, during that period, be subject to the control, superintendence and discipline of the State Election Commission".

3. In view of the above, I have been directed to request you to bring these provisions into the notice of all concerned for information and strict compliance.
