Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for the seats of Presidents and Members of all the wards of 28 Municipal Committees and 18 Municipal Councils vide Notification No. SEC/1ME/2022/1481 dated 23.05.2022 (copy enclosed). As per schedule, nomination papers shall be presented from **30.05.2022 to 04.06.2022** (except 02.06.2022 being holiday) and poll shall be held on **19.06.2022**. Re-poll if any required, shall be held on **21.06.2022** and counting of votes shall be held on **22.06.2022** at **8.00 A.M.** at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. I have, therefore, been directed to request you to declare **19.06.2022** a public holiday for all the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the municipalities, where poll shall be held on **19.06.2022**, to enable workers of the

factories, commercial establishments, shops etc. located in the areas to cast their votes.

3. I have also been directed to request you that a copy of the orders issued in this respect may kindly be sent to the State Election Commission, Haryana immediately.
