Subject: Ban on Postings/Transfers of Officers/Officials who are engaged

in conduct of bye-election of the municipal bodies in the State of

Haryana.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of bye-election for the seat of President, Municipal Committee, Dharuhera, district Rewari and of five wards i.e. Ward Nos. 3,4,7,8 & 9 of Municipal Committee, Ateli Mandi, district Mahendergarh vide Notification No. SEC/1ME/2021/3098 dated 19.08.2021 (copy enclosed). As per schedule, the nomination papers shall be presented from 27.08.2021 to 02.09.2021 (except on 29.08.2021 & 30.08.2021 being gazetted holidays) and the poll shall be held on 12.09.2021. Counting of votes shall be taken up after the close of poll in all the polling stations and the result shall be declared immediately after completion of counting.

2. I have, therefore, been directed to request you that officers/officials of the State Government deputed to conduct the abovesaid elections should not be transferred till the declaration of election results of these Municipal Committees. However, in case, where it is considered necessary unavoidable to transfer an

officer/official connected with the above said Municipal elections, prior approval of this Commission must be obtained. Necessary instructions in this regard may kindly be issued to all Departments, Boards, Corporations, Autonomous Bodies/Authorities etc. of the State Government under intimation to the State Election Commission, Haryana.
