### NOTIFICATION

**Whereas the** State Election Commission, Haryana has issued programme for the preparation of electoral roll of Municipal Council, Sirsa, vide its notification No. SEC/2ME/2020/1450, dated 13.10.2020 according to which draft electoral roll was to be published on 27.10.2020 and final publication was to be made on 27.11.2020.

2. The Deputy Commissioner, Sirsa vide his letter No. 5226/LFA, dated 30.10.2019 has informed that draft electoral roll of Municipal Council, Sirsa could not be prepared and published on 27.11.2020 due to some employees of the MC, Sirsa become Covid-19 positive, farmer agitation and technical fault in software of N.I.C., and further requested to extend the ten days for preparation and publication of ward wise draft electoral roll of municipality.

3. In view request of Deputy Commissioner, Sirsa, the Commission, hereby directs to revise the schedule for the preparation of electoral rolls of Municipal Council, Sirsa from the date of publication of draft electoral rolls as under :-

(i)	Publication of draft electoral rolls of all the wards of the municipality for inviting claims and objections [Rule- 4(3)].	05.11.2020
(ii)	Last date by which claims and objections shall be presented to the Revising Authority. {Rule -4(3)}	11.11.2020 (Except 08.11.2020 being a holiday)
(iv)	Last date by which the claims and objections shall be disposed of by the Revising Authority [Rule-4 (4) (v) & (vii)].	19.11.2020
(v)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority [Rule-4 (4) (viii)]	24.11.2020 (except 22.11.2020 being a holiday)
(vi)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	27.11.2020
(vii)	Final publication of electoral rolls .(Rule-4 (4) (ix)	05.12.2020

The Deputy Commissioner, Sirsa shall give wide publicity of the above programme.

5. The remaining instructions issued earlier by notification No. SEC/2ME/2020/1450, dated 13.10.2020 shall remain unchanged.

6. The Deputy Commissioner, Sirsa shall ensure that the electoral roll of the Municipal Council, Sirsa are prepared as per schedule given above.
