I am, therefore, directed to request you to kindly declare 27.12.2020 a public holiday for all the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the municipalities, where poll shall be held on 27.12.2020, to enable the workers of the factories, commercial establishments, shops etc. located in the areas to cast their votes.
