- 2. To facilitate the voters and the staff on duty, it is essential that the uninterrupted supply of electricity and drinking water is maintained from 26.12.2020 to 30.12.2020 in the municipalities concerned.
- **3.** I am further directed to request you to issue necessary directions to the field staff to ensure that the supply of electricity and water may not interrupted during the election of municipalities concerned.
