The said amendment may also please be brought into the notice of all Returning and Assistant Returning Officers at the time of Municipal elections to be held in future.

**No. 1/4/2020-R-II.**— In exercise of the powers conferred by clauses (c) to (g) of Sub-section (1) of Section 257, Sub-sections (2), (4) and (7) of Section 257 and Section 276 of the Haryana Municipal Act, 1973 (24 of 1973), and with reference to Haryana Government, Urban Local Bodies Department Notification No. 1/4/2020-R-II, dated 22nd April, 2020, the Governor of Haryana, hereby makes the following rules further to amend the Haryana Municipal Election Rules, 1978, namely:-

1. These rules may be called the Haryana Municipal Elections (Amendment) Rules, 2020.
2. In the Haryana Municipal Election Rules, 1978, in rule 21, sub-rule (3) shall be omitted.
