SEC/2ME/2016/235: Whereas, the State Election Commission, Haryana had prescribed a programme vide its notifications No.SEC/2ME/2016/44 and 54 dated 29.01.2016 for the preparation and the revision/updating of existing ward-wise and boothwise photo based electoral rolls in respect of all wards of Municipal Council, Kaithal and Municipal Committee Rajound respectively with reference to 1<sup>st</sup> January, 2016 as the qualifying date. iii	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-10(2)	18.03.2016
iv	Last date for disposal of appeals by the Deputy Commissioner.(Rule 10(3)	28.03.2016
V	Final publication of Electoral Rolls.(Rule-11)	08.04.2016

- 4. The Deputy Commissioner, Kaithal shall give wide publicity of the above programme.
- 5. The remaining instructions issued vide notifications no. SEC/2ME/2016/44 and 54, dated 29.01.2016 shall remain unchanged.
