The State Election Commission, Haryana vide its Notification No. SEC/2ME/2018/402 dated 23.01.2018 has issued a programme for the preparation of the electoral rolls of the sixteen municipalities including Municipal Council, Rewari on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 10.01.2018 with qualifying date as 01.01.2018. As per above said notification, the electoral roll of Municipal Council, Rewari was required to be prepared on the existing wards, as the process for the delimitation of wards of the said Municipal Council had not been completed till that time. As per programme, the draft rolls of the Municipal Council, Rewari were to be published on 06.02.2018, last date for filing claim and objections was 12.02.2018 and final electoral rolls were to be published on 12.03.2018.

- 2. Now, the Deputy Commissioner, Rewari vide his letter No. 329/LFA/202/Elec., dated 13.02.2018 has informed that application of transfer of votes from one ward to another has been received in bulk. He has also mentioned that there have been gross irregularities in draft voter list. He has further requested to allow to publication the revised draft electoral roll and also requested to revise the schedule for the preparation of electoral roll as afresh.
- 3. And now, in view of the request of Deputy Commissioner, Rewari, the Commission, hereby directs to prepare/publish the afresh draft electoral roll of Municipal Council, Rewari by distributing the electors of Assembly Constituencies (falls in the area of municipalities) into the existing wards of the Municipal Council, Rewari. The revised schedule for the preparation of electoral rolls of the Municipal Council, Rewari is hereby given as under:-
