Subject:- Amendment in the Haryana Municipal Corporation Act, 1994- reg.

Sir,

I am directed to refer on the subject noted above and to say that the Government has issued the Haryana Municipal Corporation (Amendment) Ordinance, 2016 inserting some new clauses after clause (n) in sub-section (2) of section 8 of the Act ibid, pertains to the disqualifications of the contesting or elected candidate, reproduced as under:-

After clause (n), the following clauses shall be inserted namely:-

(o) if he has been convicted, or charges have been framed against him by a court in a criminal case for an offence, punishable with imprisonment for not less than ten years; or;

(p) if he fails to pay any arrear of any kind due to him to any Primary Agriculture Co-operative Society, District Central Co-operative Bank and District Primary Co-operative Agriculture Rural Development Bank; or

(q) if he fails to pay arrears of electricity bills; or

(r) if he has not passed matriculation examination or its equivalent examination from any recognized institution/board:

Provided that in case of a woman candidate or a candidate belonging to Scheduled Caste, the minimum qualification shall be middle pass

Provided futher that in case of a woman candidate belonging to Scheduled Caste, the minimum qualification shall be 5th pass or

(s) if he fails to submit a self declaration to the effect that he has a functional toilet at his place of residence.”

In view of above, the Commission has attached a separate declaration/affidavit form with the present nomination form, which is also required by the contesting candidates to submit the same with nomination form. You are requested to bring these amendments to the notice of the Returing Officer/Assistant Returning officer concerned for strict compliance.

In addition, the Returning officer/Assistant Returning officer may also directed to obtain copies of the following documents/certificates from the contesting candidates in support of their declaration referred above:

- (i) No Due Certificate (NDC) from the concerned Power Utility.
- (ii) No due certificate from the Primary Agriculture Co-operative Society, District Central Cooperative Bank and District Primary Co-operative Agriculture Rural Development Bank, as the case may be.

(iii) Attested copy by Gazetted Officer of Educational Qualification Certificate issued by the Institution/Board concerned.
