The State Election Commission, Haryana vide Notification No. SEC/2ME/2019/582 , dated 27.02.2019 has issued a programme for the preparation of the electoral rolls of the Municipal Corporation, Sonepat on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 31.01.2019 with qualifying date as 01.01.2019. As per programme, the draft rolls of the Municipal Corporation, Sonepat were to be published on 13.03.2019, last date for filing claim and objections was 19.03.2019 and rolls were finally to be published on 15.04.2019.

- 2. Now, the Deputy Commissioner, Sonepat vide his letter No. 1185/LFA, dated 13.03.2019 has informed that he is a Returning Officer in the Lok Sabha Elections, 2019. For the conduct of these elections all the officers & officials are busy in election work. The Officers/ officials are deputed in election duty till the completion of these elections. The BLOs are presently deputed in Board Exam and Polio programme duties and due to rush of work BLOs are not available for the physical verification of preliminary voter list. As such, any error may be occurred in the preparation of preliminary voter list. No officer/ official is available for the disposal of claims and objections. The request has therefore been made to give time for the conduct of the elections of Municipal Corporation, Sonipat in view of Lok Sabha elections so that the election of Corporation may be conducted smoothly.
- 3.. And now, in view of the request of Deputy Commissioner, Sonepat, the Commission, hereby directs to revise the schedule for the prepare of electoral rolls of Municipal Corporation, Sonepat from the publication of draft electoral rolls at this time.
