In accordance with the provisions contained in Section 3A of the Haryana Municipal Act,1973 read with Rules 4 to 11 of the Haryana Municipal Election Rules, 1978 and the powers conferred under clause(1) of article 243ZA of the Constitution of India the, State Election Commission, Haryana hereby directs for the preparation of photo based electoral rolls in respect of all wards of the Municipal Committees mentioned in Annexure "B, with reference to 1st January, 2013 as the qualifying date.

- 2. The electoral rolls of these Municipal Committees shall be prepared with the help of NIC by taking a data base of the electors with photos of the relevant part of Assembly Electoral rolls finally published on 05.01.2012, with reference to 1st January, 2012 as the qualifying date and subsequent revision if any. The electoral rolls are to be prepared on the format attached at Annexure-"A". The electoral rolls of these Municipal Committees shall be prepared in accordance with the procedure and schedule given hereunder:-
- Preparation of draft electoral rolls of all ward of the 28.09.2012 (i) Municipal Committees mentioned in Annexure "B" on (Friday) the format Annexure-"A" on the basis of Assembly to Electoral Rolls published on 05.01.2012 with reference 08.10.2012 to 1st January, 2012 as the qualifying date (with all (Monday) supplements) and deleting the names of persons, who had died and also of those who are found to be no longer ordinarily resident in the territorial limits of the Municipal Committees. (Rule-4) (ii) Draft publication of electoral rolls of all the wards of the 09.10.2012 Municipal Committees as referred in sub para (i) (Tuesday) above for inviting claims and objections.(Rule-7)
- (iii) Last date by which claims and objections shall be presented to the Revising Authority. (Rule-9) (Wednesday)
- (iv) Last date by which the claims and objections shall be disposed of by the Revising Authority. (Rule-10(1)(i)(ii))

(v)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-10(2))	05.122012 (Wednesday)
(vi)	Last date for disposal of appeals by the Deputy Commissioner.(Rule 10(3))	20.122012 (Thursday)
(vii)	Final publication of electoral rolls.(Rule-11)	05.01.2013 (Saturday)

- 3. It is further directed that database with photo images of the electors and four copies of Assembly electoral rolls finally published on 05.01.2012 and subsequent revision if any, with reference to 1st January, 2012 as qualifying date shall be obtained free of cost from the Election Tehsildar/Election Naib Tehsildar, concerned.
- 4. It is further directed that while preparing the draft electoral rolls, it should be ensured that names of the persons, who had died and also of those who are found to be no longer ordinary residents within the limits of the Municipal Committee, but their names are still existing in the Assembly electoral rolls finally published on 05.01.2012 and subsequent revision if any, **should not** be included in the draft electoral rolls of the Municipal Committee, concerned.
- 5. It is further directed that names of the eligible persons who shall attain the age of 18 years on 01.01.2013 and also fulfill the qualifications prescribed under rule 6 shall be included in the electoral rolls.
- 6. It is further directed that:-
 - (i) The Deputy Commissioner shall give wide publicity to the above programme. He shall issue press notes and also paid advertisements in two local newspapers. He shall also make publicity through local cable network.
 - (ii) As soon as the draft electoral roll is ready, the Deputy Commissioner shall publish, on the date prescribed in sub-para(ii) of para 1 above, the same together with a notice including the dates by and the places where the claims and objections with reference to the draft rolls may be presented to the Revising Authority/Authorities.

- iii) One copy of the draft electoral roll, published for inviting claims and objections, shall be kept for inspection of the public free of cost at the following places:
 - a. Office of Deputy Commissioner,
 - b. Office of Secretary of the Municipal Committee concerned,
 - c. Office of Sub-Divisional Officer(Civil)'s concerned,
 - d. Tehsil Office concerned.
 - e. Office of Revising Authority/Authorities and
 - f. Voter Information and Collection Centers
- (iv) After the draft publication of the ward-wise electoral rolls, the same should also be hosted on the website of the District Administration and this Commission with search facility, for information of the public.
- (v) A copy of the draft and final rolls shall be signed by the Revising Authority and shall be kept in a sealed cover in the Treasury.
- (vi) In order to facilitate the electors and the public to obtain information regarding electoral rolls and to file claims and objections, the Deputy Commissioner concerned shall set-up suitable numbers of voters Information and Collection Centers (VICC) within the territorial limits of the Municipal Committee concerned. These centers shall be fully equipped with computers and broadband internet connection. The center will be set up with the help of the NIC.
- (vii) The VICC centers will make available the prescribed forms, on demand free of cost, for filing claims and objections and receive the same for the consideration of and decision by the concerned Revising Authority or the officers authorized for this purpose. The forms shall also be hosted on the website of the State Election Commission and the District Administration. The forms can be downloaded and used by any person for filing claim and objection.
- (viii) As and when any person files claim and objection, he shall be given a receipt in the prescribed format given in the form.

- (ix) The Deputy Commissioner shall appoint one Authorized Officer not below the rank of Group B officer for maximum up to three wards and sufficient number of required supporting staff and other officials of Municipal Committee, to assist the Revising Authority/Authorities to discharge his/their duty.
- (x) The Revising Authority/Authorities shall, after holding such enquiry into the claims or objections as he/they think(s) fit as per rules, record his/their decision in writing and shall make available forthwith a copy of such decision to the objector or claimant free of charge. The decision of the Revising Authorities shall also be hosted on the website for the information of the public. Number of claims/objections accepted and rejected shall also be hosted on the website of the District Administration. The software of the NIC shall be used for this purpose.
- (xi) The Revising Authority/Authorities after disposal of all the claims and objections in terms of under Sub-rule(1) of Rule 10 of the Haryana Municipal Election Rules, 1978 shall forward a list of such claims and objections along with his/their orders thereon to the concerned Deputy Commissioner. Any person aggrieved of any such order of the Revising Authority/Authorities may, within prescribed period, file an appeal to the Deputy Commissioner. The Deputy Commissioner shall within the specified time decide the appeal. The decision of the Deputy Commissioner on appeal shall be final.
- (xii) The Deputy Commissioner shall publish the final electoral rolls on 05.01.2013 and the Electoral Rolls of the Municipal Committee concerned shall come into force from the date of publication.
- (xiii) After completion of every stage of the preparation of electoral rolls process as stated above, the concerned Deputy Commissioner shall send information of the statistical data in format Annexure "B" to the State Election Commission, Haryana.

- 7. It is further directed that copy of ward-wise draft electoral rolls of the Municipal Committee concerned finally published on 05/01/2013 shall be submitted to the State Election Commission, Haryana on the same day. In addition, two copies of the electoral rolls along with a compact disc. containing the database of the same in PDF format shall be sent to all the political parties in the State of Haryana on the same day under intimation to the Commission.
- 8. It is further directed that the final electoral rolls of Municipal Committee concerned shall be hosted on the website of the District Administration on the day they are published.
