Subject : **Municipal Bye Election November, 2013 --- Model Code of Conduct.**

Sir,

I am directed to address you on the subject noted above and to say that the State Election Commission, Haryana vide its notification No.SEC/1ME/2013/5318, dated 26.11.2013 has issued the election programme for holding the bye elections of ward No.22, Municipal Council, Narnaul , ward No.2, Municipal Committee, Safidon, Distt. Jind and ward No.10 of Municipal Committee, Hathin, Distt.Palwal.

2. As the election programme has been declared by this Commission on 26.11.2013, the Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f. 26/11/2013 in the above said wards of the municipalities.

3. I am, therefore, directed to request you that the above provisions may be brought to the notice of Hon'ble Chief Minister/Ministers/Chief Parliamentary Secretaries/ Parliamentary Secretaries and other authorities and they may be requested to strictly follow the same. I am further directed to request you to invite attention of Hon'ble Chief Minister/Ministers/Chief Parliamentary Secretaries/Parliamentary Secretaries towards Para No.9 of the Model Code of Conduct that no grant be sanctioned by them from the discretionary fund or from the Govt. fund nor will they sanction any scheme till elections are completed in all respect. During this period, neither any foundation stone shall be laid nor will any scheme / plan be inaugurated. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.

4. I am further directed to say that State Election Commission will not hesitate to cancel the election in respect of above said wards of the municipalities in case of any violation of the Model Code of conduct.
