PRESS NOTE

Panchkula 2nd June, 2016: Dr. Dalip Singh, State Election Commissioner, Haryana has informed that the General Election of Municipal Corporation, Gurugram is to be conducted in near future for which programme for the preparation of wardwise Electoral rolls has been issued today. As per programme, the Electoral Rolls of the Corporation are to be revised as per the schedule given below:

PROGRAMME

(i)	The wardwise and boothwise photo based Draft Electoral Rolls of all wards of the Municipal Corporation, Gurugram shall be prepared as per delimitation published by the Government vide notification No.18/4/2017-3C1 dated 1 st June, 2017 in the format Annexure 'A' on the basis of latest database of the Assembly electoral rolls published on 10 th January, 2017 with reference to 1 st January, 2017 as qualifying date with supplements. [Rule-4 (1)].	06.06.2017 to 21.06.2017
(ii)	Publication of Draft Electoral Rolls of all the wards of the Municipal Corporation as referred in sub para (i) above for inviting claims and objections. [Rule- 4(3)]	22.06.2017
(iii)	Last date by which claims and objections shall be presented to the Revising Authority. [Rule-4(4)(i)]	28.06.2017 (up to 03.00 PM)
(iv)	Last date by which the claims and objections shall be disposed of by the Revising Authority. [Rule-4 (4) (v)& (vii)]	05.07.2017 (except 02.07.2017)
(v)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-4 (4) (viii)]	08.07.2017
(vi)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	12.07.2017 (except 09.07.2017)
(vii)	Final publication of Electoral Rolls.(Rule-4 (4) (ix)	20.07.2017

2. Dr. Singh further added that earlier the electoral rolls of the Municipalities were being prepared on the basis of the electoral rolls of the respective Legislative Assembly Constituencies and new voters were also being included in these rolls. But, as per the amendment made by the Government in the Haryana Municipal Corporation Election Rules, 1994 vide Notifications No. 4/4/2017-R-II dated 14th March, 2017, such practice has been discontinued. As per new amendment, only the electors existed in the respective area of the Legislative Assembly Constituency shall be distributed in the wards of the Municipal Corporation. So, if any person intends to include his name in the electoral roll of Municipal Corporation, he should have to first included his name in the electoral rolls of respective Legislative Assembly Constituency; otherwise his name shall not be included in the electoral rolls of Municipal Corporation.

3. Dr. Singh also added that any person whose name is not included in the finally published ward wise electoral rolls of Municipal Corporation, he may apply to the Deputy Commissioner for addition/deletion/correction of his name. But, any <u>addition/deletion/</u> <u>correction in name can only be made, if the name of the claimant exists in the relevant part of Assembly Electoral Roll till the first day of filing nomination papers</u>.
