Sir,

I am directed to refer on the subject noted above and to say that General Election of Municipal Committees Taoru (Mewat), Haily Mandi, Pataudi (Gurgaon), Kharkhoda (Sonipat), Indri & Nilokheri (Karnal), Kalayat & Pundri (Kaithal), Narnaund (Hisar), Siwani & Bawani Khera (Bhiwani) and Beri (Jhajjar) are to be held in near time in the year 2013. The State Election Commission, Haryana has issued a programme for preparation of photo based electoral rolls of these municipalities vide its notification No.SEC/2ME/2012/1455 dated 25.09.2012 (copy enclosed). As per programme, the process for preparation of draft electoral rolls shall be commenced from 28.09.2012. The draft electoral rolls shall be published on 09/10/2012 and subsequent claims and objections shall be received by the Revising Authority concerned by 31.10.2012. The final publication of electoral rolls shall be done on 05.01.2013.

2. Therefore, I am further directed to request you that officers/officials of the State Government posted in District concerned, who are connected with the preparation of electoral rolls of these Municipalities including the supporting staff officers/officials of the concerned Municipalities may not be transferred till the final publication of the electoral rolls under reference. In such cases, where it is considered necessary to transfer any officer connected with the preparation of electoral rolls of these Institutions, approval of the State Election Commission may be obtained. Instructions in this regard may kindly be issued to all Head departments of the State Government under intimation to the State Election Commission.
