<u>ORDER</u>

No.SEC/3ME/2012/333

Dated:-14/03/2012

As per provisions contained in Section 13 D and 13 E of Haryana Municipal Act, 1973, every contesting candidate of Municipal Council has to maintain an account of his election expenses from the date of his nomination till the declaration of result. The State Election Commission, Haryana, vide its notification No. SEC/4ME/2006/9706, dated 19.12.06, has fixed the time limit of 30 days from the date of declaration of the result of the election to file/lodge account of election expenses with the Deputy Commissioner or any other officer prescribed by the State Election Commission, Haryana and the Commission vide its notification No.SEC/3ME/2003/10216, dated 24/10/2003, has also prescribed the election expenditure limit of Rs.50,000/- for the contesting candidate of the Municipal Council. If a candidate does not file his election expenditure statement within the prescribed time limit or make expenditure beyond prescribed expenditure limit could be disqualified by the State Election Commission, Haryana for a period of three years.

2. The General election to Municipal Council, Jind, District Jind, was held on 20.05.2010 and the result was also declared on the same day. Therefore, election expenses account were to be filed by 19.6.2010. The following 121 candidates had failed to lodge account of their election expenses within 30 days of declaration of the result:-

They were served upon with a show cause notice as to why they should not be disqualified as they did not file the election expenses account within the prescribed time. They were personally heard by me on 10.02.2012 at 11.30 A.M. in the Court Room of Deputy Commissioner, Jind. Out of 119 candidates, 7 candidates mentioned at Sr. No. 9, 16, 26, 42, 72, 81 and 116 have submitted their accounts to the Commission alongwith replies to the Show Cause notice stating that they were not aware of the rules regarding submission of the election expenditure register account. Sh.Surinder s/o Sh.Prabhu Ram in his reply stated that he has deposited the expenditure register to Sh.Satbir and Sh.Lal Chand but at the time of hearing, he could not submit any receipt

4. At the time of personal hearing on 10.02.2012, out of 119 candidates, 53 candidates mentioned at Sr.No. 1, 2, 4, 7, 9, 10, 11, 12, 17, 18, 20, 21, 23, 26, 27, 28, 32, 35, 42, 43, 44, 45, 48, 49, 52, 55, 56, 57, 58, 61, 65, 67, 68, 70, 75, 77, 78, 79, 81, 82, 89, 99, 100, 106, 108, 109, 110, 111, 112, 113 & 116 appeared for personal hearing and two candidates mentioned at Sr.No. 6 and 95 were represented by their respective husbands. The following submissions were made by the above mentioned persons:-

i) 38 candidates mentioned at Sr. No. 1, 2, 4, 6, 7, 10, 12, 18, 21,23, 28, 35, 43, 48, 49, 52, 55, 56, 57, 58, 61, 67, 68, 70, 75, 77, 79, 82, 89, 95, 99, 106, 108, 109, 110, 111, 112 & 113 stated that they were not aware about rules

regarding deposit of the expenditure register. For this and other reason, they could not deposit the expenditure register.

ii) 17 candidates mentioned at Sr. No. 9, 11, 16, 17, 20, 26, 27, 32, 42, 44, 45, 65, 72, 78, 81, 100 & 116 stated that they were not aware about deposit of the expenditure register and they have deposited their expenditure register after issuance of show cause notices either in the office of the State Election Commission or before the Hon'ble State Election Commissioner at the time of hearing.

5. From the records and based on the submission made at the time of hearing, 17 candidates mentioned at Sr. No. 9, 11, 16, 17, 20, 26, 27, 32, 42, 44, 45, 65, 72, 78, 81, 100 & 116 have deposited their election expenditure statement after the prescribed time. On perusal of record of the case and hearing of the candidates mentioned above, it has been observed that the candidates are generally not aware of the procedure of filing the election expenditure statement and consequently they do not submit such statement in time. Most of them have submitted expenditure account after receipt of show cause notices. Therefore, in view of the above and taking a lenient view in the matter, the 17 candidates mentioned above are hereby exempted from filing their election expenditure statement beyond the prescribed time with warning not to repeat such lapse in the future.

Remaining 102 candidates mentioned at Sr. No. 1, 2, 3, 4, 5, 6, 7, 8, 10, 12, 13, 14, 15, 18, 19, 21, 22, 23, 24, 25, 28, 29, 30, 31, 33, 34, 35, 36, 37, 38, 39, 40, 41, 43, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 66, 67, 68, 69, 70, 71, 73, 74, 75, 76, 77, 79, 80, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 117, 118 & 119 of para 2 have not submitted statements of expenditure so far, they all are hereby disqualified for a period of 3 years from the date of this order.
