Whereas, the State Election Commission, Haryana vide its notification No. SEC/3E-III/2009 dated 29.10.2009 has notified twenty four free symbols for the allotment of candidates contesting the elections for the seat of Sarpanch.

- 2. Whereas, the Block Development and Panchayat Officer, Bhuna district Fatehabad vide his Memo No. 380 dated 26.05.2010 has informed that 85 candidates have filed the nomination paper in Gram Panchayat Gorakhpur, 48 in Gram Panchayat, Bhuna, 43 in Gram Panchayat, Nehla and 26 in Gram Panchayat, Jandli for contesting the election of the seat of Sarpanch. He has thus made a request to provide additional symbols so that they may be allotted to all the contesting candidates.
- In view of the above position, in exercise of powers conferred under sub rule (2) of rule 33 of the Haryana Panchyati Raj Election Rules, 1994, the State Election Commission, Haryana hereby directs that after the allotment of twenty four free symbols in an alphabetically order in Hindi in Alphabate "¾" onwards, to the candidates contesting the election of the seat of Sarpanch, the allotment of free symbols to the remaining contesting candidates be further made in an alphabetically order from the remaining free symbol of Zila Parishad and Panchayat Samiti respectively.
- 4. It is also directed that allotment of symbol for the post of Sarpanch shall be withheld in the case where the candidate exceed 24 till the completion of allotment of symbol of Zila Parishad and Panchayat Samiti. The Deputy Commission-cum-District Election Officer(Panchayat) shall make available a list of remaining free symbols of Zila Parishad and Pancahyat Samiti to the Returning Officer/Assistant Returning Officer for the post of Sarpanch.
- 5. Seriatim of the symbol shall be fixed for the post of Sarpanch as the Commission has already fixed 24 symbols for the post of Sarpanch and thereafter Sr. No,. 25 will start from remaining symbols of Zila Parishad and thereafter Panchayat Samiti. It may also be ensured that Sr. No. of free symbols for the post of Zila Parishad

and Panchayat Samiti already fixed by the Commission shall not be disturbed only the Sr.No. of remaining symbols shall be added in the symbol added after Sr. No. 24.
