

**STATE ELECTION COMMISSION, HARYANA
S.C.O. NO. 16-17, SECTOR 20-D, CHANDIGARH.**

NOTIFICATION

No.SEC/2ME/2007/03

Dated:02.01.2007

Whereas, a vacancy on account of death of Sh. Hawa Singh S/o Sh. Jai Lal, Member, Ward No. 29 of Municipal Corporation, Faridabad on 23.06.2006 has occurred.

2. And whereas, sub section (1) of section 13 of Haryana Municipal Corporation Act, 1994 provides whenever a vacancy occurring by death, resignation or removal or by vacation of a seat for any other reason, the vacancy shall be filled with in six months of occurrence of such vacancy.

3. Now, the State Election Commission, Haryana in exercise of the powers conferred on it under clause (1) of Article 243ZA of the Constitution of India read with Section 9 of the Haryana Municipal Corporation Act, 1994, has decided to prepare the electoral rolls of all the wards of Municipal Corporation, Faridabad summarily w.r.t. 01/01/2007 as the qualifying date, and on the basis of Assembly Electoral Rolls which were published on 31.05.2006 with reference to 1st January, 2006 as qualifying date, as per following programme:-

1.	Preparation of Draft Electoral Rolls of all the wards of the Municipal Corporation, Faridabad on the basis of Assembly Electoral Rolls finally published on 31.05.2006 with Qualifying date as 01.01.2006 (Rule-4 of Haryana Municipal Corporation Election Rules, 1994) and also adding the names of eligible persons who have attain the age of 18 years on 01-01-2007.	08.01.2007 to 17.01.2007
2.	Draft publication of electoral rolls of all the Wards of the Municipal Corporation, Faridabad w.r.t. 01-01-2007 as qualifying date for inviting claims and objections (Rule-7 of the rules ibid)	18.01.2007
3.	Last date by which claims and objections shall be presented to the Revising Authority (Rule-9 of the rules ibid)	29.01.2007
4.	Last date by which the claims and objections shall be disposed of by the Revising Authority. (Rule-10(1)(i) and (ii) of the rules ibid)	05.02.2007
5.	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority (Rule-10(2) of the rules ibid)	08.02.2007
6.	Last date for disposal of appeals by the Deputy Commissioner (Rule-10(2) of the rules ibid)	15.02.2007
7.	Cyclostyling/photocopy/typing of finally publishing of addenda to the existing electoral rolls meaning thereby addition or deleting of names in the form of supplementary addenda appending to the electoral rolls (Rule-11 of the rules ibid)	23.02.2007

6. The State Election Commission further directs that all the names of the electors entered in the Assembly Electoral Rolls finally published on 31.05.2006 and also in the existing Municipal Electoral rolls finally published on 31.03.2005 except the names of the persons who have died and also of those who have ceased to be ordinary resident or no longer ordinarily residing in the territorial area of the concerned wards of the Municipal Corporation should be included/deleted in the ward wise draft of the Municipal rolls now to be prepared for publishing them to invite claims and objections.

7. The State Election Commission further directs to use the Electoral Rolls of Haryana Assembly finally published on 31.05.2006 w.r.t. 01/01/2006 as the qualifying date. Copy of electoral rolls of Haryana Assembly may be obtained from the Election Department, Haryana. Requisite format prescribed for the Municipal Rolls, as "Annexure-1" attached herewith is required to be typed (not to be printed).

8. The State Election Commission further directs that:-

- (a) The Deputy Commissioner shall give widest possible publicity to the above programme indicating place and time of receiving & disposal of claims and objections by the Revising Authority/ies and disposal of appeals by the Deputy commissioner, Faridabad. He will issue press notes and also paid advertisements in the two local newspapers. He will also make publicity through electronic media.
- (b) One copy of the draft electoral rolls published for inviting claims /objections shall be made available to the Commissioner, Municipal Corporation, Faridabad, one copy in the office of concerned Tehsildar, one copy in the office of concerned Sub-Divisional Officer (Civil), copy to the concerned Revising Authority/ies and one copy be kept in the Deputy Commissioner's office, for making it available for inspection of the public free of cost.
- (c) The Deputy Commissioner shall publish the ward-wise draft Municipal Electoral Rolls together with a notice including the date 29.01.2007 by which the claims & objections with reference to the draft Rolls, may be presented to the Revising Authority/ies. The Deputy Commissioner shall appoint One Authorised Officer on three Wards and sufficient number of required supporting staff and other officials of Municipal Corporation,

Faridabad, to assist the Revising Authority/ies for providing copies of the Draft Municipal Electoral Rolls for inspection of public and also to receive claims & objections. After the draft publication of the ward-wise Municipal Electoral Rolls made on 18.01.2007, these draft Municipal Electoral Rolls should be made available to the public for consultation and inspection at some prominent places also, preferably at Government or Municipal buildings and for this purpose Centres dividing with three Wards i.e. assigning three Wards to each centre and last centre assigning remaining wards for Municipal Corporation, Faridabad, should be created under the charge of an Authorised Officer and at these centres, the ward-wise draft Electoral Rolls should be placed for supervision of the Authorised Officer assisted by supporting staff so that after inspection of these ward-wise draft Electoral Rolls, the aggrieved person/(s) can file claims and objections before the Authorised Officers and proper receipts for these claims & objections filed before them, should also be issued to the person/(s) who have filed before them, and these Officers should also inform them the date, time and place of disposal of their claims & objections by the Revising Authority/ies as prescribed by them.

- (d) The Revising Authority/ies shall, after holding such enquiry into the claims or objections as he/they thinks fit, record his/their decision in writing and shall make available on demand a copy of such decision to the objector or claimant free of charge forthwith.
- (e) The Revising Authority/ies after disposal of all the claims & objections in terms of under sub-rule (1) of Rule 10 of the Haryana Municipal Corporation Elections Rules, 1994, shall forward a list of such claims and objections along with his orders thereon to the Deputy Commissioner, Faridabad, within the prescribed time. Any person aggrieved of any such order of the Revising Authority/ies, may within three days apply to the Deputy Commissioner for revision of the orders of the Revising Authority/ies. The Deputy Commissioner shall within a period of five days confirm such order, or set it aside or pass such order with respect to such claim or objection as he may deem fit. The decision of the Deputy Commissioner on appeal shall be final.

- (f) The Deputy Commissioner shall publish the final Electoral Rolls on 23.02.2007 and the Electoral Rolls of the Municipal Corporation, Faridabad, shall come into force from the date of publication.
- (g) After completion of every stage of the preparation process, the Deputy Commissioner, Faridabad, shall invariably send a message to the State Election Commission and shall also keep the State Election Commission informed of the Statistical Data like the numbers of claims objections and corrections received accepted and rejected.

9. The State Election Commission further directs that a copy of ward-wise Municipal Electoral Rolls of Municipal Corporation, Faridabad, finally published on 23.02.2007 shall be submitted to the State Election Commission on the same date and one copy each thereof shall be supplied to all the recognised Political Parties in the State of Haryana under intimation to the State Election Commission.
