No. SEC/IME/2006/6638: Whereas, consequent upon the death on 01.01.2006 of Sh.Devi Dayal S/o Sh.Tara Chand, Member Ward No.11 of Municipal Committee, Kalayat, Distt. Kaithal a vacancy in Ward No.11, Municipal Committee, Kalayat, Distt. Kaithal has occurred.

2. And, Whereas, consequent upon the disqualification of Sh.Kapoor Singh S/o Sh.Mahabir Singh Member Ward No.3 of Municipal Committee, Bawani Khera, a vacancy in Ward No.3, Municipal Committee, Bawani Khera has occurred vide this Commission oder dated 24.05.2006.

3. And Whereas, consequent upon the death on 05.02.2006 of Smt.Parkash Kaur W/o Sh.Surjeet Singh, Member Ward No.10 of Municipal Committee, Nilokheri, a vacancy in Ward No.10, Municipal Committee, Nilokheri, Distt. Karnal has occurred.

4. And, Whereas, the State Election Commission vide its notification No.SEC/1ME/2005/1871, dated 15.04.2005, on the request of State Government vide its letter No.2AE/2005/16365, dated 15.04.2005 cancelled the election programme of Ward No.1, 2, 3, 10, 11, 12 & 28 of Municipal Council, Karnal which was sheduled to be held on 16.04.2005. Now the State Government (Urban Development Deptt.) vide its notification No.18/5/2003/3C1, dated 12.07.2006 has excluded certain area from the Municipal Council, Karnal. Thereafter the State Govt. (Urban Development Deptt.) vide its order No.18/53/2004-3C1, dated 17.07.2006 has modified the boundaries of Ward No.1, 2, 3, 10, 11, 12 & 28. Due to modification of boundaries of the said wards under Rule 10 of the Haryana Municipal Delimitaion of Wards Rules, 1977 and further clarified that there are no

electors in the area of Ward No.1 & 12 of Municipal Council, Karnal. Therefore, to fill up the vacant seats of members a bye-election is needed to be conducted only in Ward No.2, 3, 10, 11 & 28 of Municipal Council, Larnal for the remaining term of Municipal Council, Karnal.

5. And, whereas, as per provisions contained in Section 15 of the Haryana Municipal Act, 1973 and amendments made therein from time to time, such casual vacancies are to be filled within six months of the occurrence of such vacancies.

6. Now, therefore, in exercise of powers vested under clause (1) of Article 243ZA of the Constitution of India, Section 3A of the Haryana Municipal Act, 1973 and rule 19(1) of the Haryana Municipal Election Rules, 1978 and all other powers enabling me in this behalf, I, Chander Singh, State Election Commissioner, Haryana hereby frame the following election programme for the conduct of Municipal Bye-Elections for remaining period in Ward No. 11 of Municipal Committee, Kalayat, Distt. Kaithal, Ward No.3 of Municipal Committee, Bawani Khera in Distt. Bhiwani, Ward No.10 of Municipal Committee, Nilokheri and Ward Nos.2, 3, 10, 11 & 28 of Municipal Council, Karnal of District Karnal:

7. The Returning Officers shall publish the above election programme on 06/09/2006 by way of notices to be posted at their offices, at the office of the concerned Deputy Commissioner, at the offices of the Municipal Council/Committees and at such other conspicuous places in the Municipal area of the Municipal Council/Committees in which the election would be held as may be determined by them in this behalf under Rule 20 of the Haryana Municipal Elections Rules, 1978.

8. <u>The State Election Commission further directs that the Returning</u> Officer, Municipal Council, Karnal may scrutinize the nomination papers which are kept in intact as per direction given by the State Election Commission, Haryana vide its notification No. SEC/1ME/2005/1871, dated 15/04/2005. The candidates of Ward No. 1 and 12, who have filed their nomination papers during the General Elections may also be allowed to change his Ward No. as the election to Ward Nos. 1 and 12 could not be conducted due to modification of the Wards by the State Govt. (Urban Development Deptt.) vide its order dated 17.07.2006.

9. The State Election Commission further directs that while supplying the nomination papers to the intending candidates, the concerned Returning Officer shall inform them in the manner prescribed in **Annexure-I** attached herewith that they should file an affidavit in **Annexure-II** attached herewith alongwith the required information under Section 8 of the Representation of the People Act, 1951 and Section 13A(1) of the Haryana Municipal Act,1973 in the performa enclosed with Annexure-II and also another affidavit in **Annexure-III** for disclosure of information about the convictions and acquittals/ discharged of criminal offences, pending criminal cases and details of assets & liabilities and educational qualification as required under the Commission's order No. SEC/E-III/2003/8831, dated 6.10.2003. The Returning Officer shall give copies of the **Annexure II and III** referred to above, to the intending candidates alongwith a copy of nomination papers (i,e, Form-1) so that the candidate may file these affidavits alongwith the nomination papers to be submitted to the Returning Officers.

10. The State Election Commission further directs that on receipt of the nomination papers, if a candidate does not file any of the two affidavits in **Annexure-II** or **Annexure-III** or both these affidavits, then the concerned Returning Officer shall issue a notice as in **Annexure-IV** to the person delivering the

nomination paper that the candidate should file the affidavit(s) immediately and positively before 10.00 A.M. of the date of scrutiny of nominations failing which the nomination papers of the candidate shall be rejected.

11. The State Election Commission further directs that on receiving the nomination papers under sub-rule (1) of Rule 20 of the Haryana Municipal Elections Rules, 1978, the Returning Officers shall inform the person or persons delivering the same, in the format as in **Annexure-V** annexed to this notification, the date, time and place fixed for the scrutiny of the nomination papers and shall enter on the nomination paper its serial number and sign thereon a certificate stating the date on which and the hours at which the nomination papers have been delivered to him and shall as soon as may be thereafter cause to be affixed in some conspicuous places in their offices, the notices of the nominations containing description similar to those contained in the nomination papers, both of the candidates and proposer.

12 The State Election Commission also directs that the information furnished by each candidate in the Affidavit in Annexure-II and III of the Commission's instructions No. SEC/ME/2003/9268-86 dated 15/10/2003 shall be disseminated by the concerned Returning Officers by displaying a copy of the affidavit on the notice board of his office and also by making copies thereof available to all the other candidates on demand and to the representatives of the Print and Electronic media. If any rival candidate furnishes information to the contrary, by means of duly sworn affidavit, then such affidavit of the rival candidate shall also be disseminated alongwith the affidavit of the candidate concerned in the manner said above.

13 The State Election Commission further directs that immediately after the expiry of the period within which candidatures may be withdrawn under Rule 28 of the Haryana Municipal Elections Rules, 1978, the concerned Returning Officers shall prepare in Hindi the lists of contesting candidates, that is to say, lists of candidates who have been included in the lists of validly nominated candidates, and those who have not withdrawn their candidatures within the prescribed period. The lists shall be caused to be posted at the some conspicuous place, in the office of the Returning Officer or at the Municipal Counci/Comittees office.

14. The State Election Commission further directs that the concerned Returning Officer or the Assistant Returning Officer as the case may be, shall at every stage prepare the notices of the nominations containing descriptions similar to those contained in the nomination papers both of the candidates and the proposers, the lists of candidates whose nomination papers have been rejected, the list of validly nominated candidates, the notices of withdrawal of candidatures and the lists of contesting candidates and affix the same at some conspicuous places, at the notice board of their offices and at the office of the Municipal Council/Committees and shall submit one copy thereof to the State Election Commission directly at every stage and one copy through the concerned Deputy Commissioner.

15. The State Election Commission further directs that the counting of votes polled at the elections to the seat of Member of Municipal Council shall be taken up at the respective polling stations on the date of Poll immediately after the close of the poll. The details (account) of the ballot papers polled at each polling station shall be prepared on Form 7 by the Presiding Officer and forwarded to the Returning Officer for consolidation of accounted ballot papers on Form 8 mentioning therein the total number of valid votes polled in favour of each candidate on each polling station and declare the candidate who is found to have been obtained largest number of votes elected as Member from the ward.

16. The State Election Commission further directs that after the declaration of result of elections under Rule 62, the Returning Officers shall forthwith post a copy of return (i.e. Form 8 - Consolidation of account of the counted ballot papers) in a conspicuous place at his office and send with a copy

thereof to the concerned Deputy Commissioners, who shall immediately forward the names of the elected candidates to the State Election Commissioner, Haryana for notifying the same in official gazette. The Deputy Commissioners shall ensure that the names and other particulars of the elected candidate should be the same as are recorded in the nomination paper.
